I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled <u>Joyce Miller (Zsibrita)</u>, et al. v. City of <u>Los Angeles</u>, et al., Los Angeles Superior Court, Lead Case Nos. BC316318 and BC356529 (this matter arises from an incident involving members of the Los Angeles Police Department), **SUBJECT TO THE APPROVAL OF THE MAYOR**:

- 1. AUTHORIZE the City Attorney to expend up to \$890,600 in settlement of the above-entitled matter.
- 2. AUTHORIZE the Controller to transfer \$890,600 from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009792, Police Liability Payouts.
- 3. AUTHORIZE the City Attorney to draw demands from Fund No. 100/59, Account No. 009792, Police Liability Payouts as follows:
  - a. Up to \$285,600 made payable to CPT Group, Inc.
  - b. Up to \$605,000 made payable to Johnson and Johnson, LLP.
- 4. AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.
