Re: Clean Up Green Up – proposed amendment to LA Building Code to require mechanical filtration in buildings within 1000 feet of freeways


IQAir supports the proposal being submitted by the Department of Building and Safety (DBS) to amend the Los Angeles Building Code's mechanical air filtration requirement for new and substantially rehabilitated buildings located within 1000 feet of freeways to include higher filtration efficiency levels. Our understanding is that the proposal recommends that the air filters' Minimum Efficiency Reporting Value (MERV) ratings be at least MERV 13 for both residential and nonresidential buildings. It is a great first step towards providing equal air quality for people who have to live and/or work near busy highways.


For the past seven years, IQAir has been working with South Coast Air Quality Management District (AQMD) to provide cleaner air to children in schools located in close proximity to pollution hotspots, such as refineries, ports, railyards, and busy highways. Our MERV 16 rated high performance HVAC air filters have been shown to dramatically reduce indoor pollution levels for ultrafine particles (UFPs) and diesel soot by up to 90%. Bear in mind that this involves upgrading the classrooms' existing legacy HVAC systems—not installing expensive new hospital-grade HVAC equipment—so this is why we know that it is possible to provide a "clean air safe haven" for the inhabitants of buildings located close to freeways.

This is also why IQAir urges going one step further, and recommends the use of MERV 16 filters for both residential and non-residential buildings. The reason for it is simple: it is to compensate for the fact that this type of high efficiency/ high airflow filter tends to lose filtration efficiency over time when battling highway pollution. A filter than starts out at MERV 13 might drop down to MERV 10 levels by the time it gets replaced, and that means the inhabitants could be exposed to a lot more air pollution than the amendment had intended. By starting out at a higher efficiency level, it is possible to maintain at least the MERV 13-level filtration efficiency over the entire life of the filter. There is actually a filter rating scale that describes a filter after its efficiency has dropped due to such pollution challenges; unfortunately, hardly ever is a filter marketed by its MERV-A rating nor are most people even aware that such a test standard even exists. whereas it might make sense to support a MERV-A rating of 13-A, it is probably wiser to state the requirement in terms people understand, and that is why we recommend simply jumping up to a MERV 16 rating.





One of the potential objections we often hear concerns the airflow resistance (aka. "pressure drop") often associated with high efficiency filters. Whereas that may have been true in the past, current technology affords the possibility of combining high filtration efficiency while still allowing air to flow relatively easily through the filter. The industry is catching up and ASHRAE now has updated standards and guidelines that better reflect the current state of technology. Taking that into consideration, IQAir recommends that these MERV 16 filters have a pressure drop of less than 0.2" wc for residential applications, and 0.4" wc for non-residential applications for new filters. Typical HVAC systems in good working condition should be able to handle these airflow resistances without problem.

In terms of cost, the higher efficiency filters have a more expensive unit price than what people are currently spending on their low efficiency filters. But in some cases, the higher efficiency filters might also last twice as long. When combined with the labor savings for replacing filters less often, this helps mitigate the price differential when upgrading to filters that actually provide clean air for the building's occupants.

When viewed from a total cost of ownership perspective, stepping up to MERV 16 filters only costs about three times as much as the MERV 8 filters that are typically installed in buildings.



IQAir applauds the efforts by Clean Up Green Up and the LA Department of Building Safety to amend the Building Code in order to help provide equal air quality for people who live and/or work near busy highways. "California leads the nation," and this would be a great opportunity for Los Angeles to pave the way for better air quality across the country.

RE: Clean Up Green Up—Proposed Amendment to Los Angeles Building Code to Require Mechanical Filtration in Buildings within 1,000 of Freeways (Council File 15-1026)

Dear Honorable Members:

As members of the LA Collaborative for Environmental Health & Justice, we respectfully submit this letter in support of the proposal, as we understand it, being submitted by the Department of Building and Safety (DBS) to amend the Los Angeles Building Code to require mechanical air filtration in new and substantially rehabilitated buildings located within 1,000 feet of freeways at the level of Minimum Efficiency Reporting Value (MERV) of 13 or higher. We are pleased to see the DBS recommending this important next step in protecting the health of persons who live or work in proximity to freeways.

There has been substantial documentation over the years of the health impacts, especially on vulnerable populations, of exposure to the mix of pollutants that are generated from vehicle traffic on freeways. The California Air Resources Board (ARB) notes that such emissions "have been associated with a variety of serious health impacts in epidemiological studies, including exacerbation of respiratory and cardiovascular diseases and conditions, increased asthma and bronchitis in children, and increased risk of premature death. Traffic pollutant concentrations near high traffic roadways have been found to be 2 to 10 times higher than levels at a distance from the roadways."¹ Various studies have documented that these concentrations are most severe within 300 to 500 meters (roughly 900 to 1,500 feet) of such roadways, leading to recommendations that special attention be given to placing sensitive populations, and the structures they occupy, within such distances. In recognition of such analyses, ARB has recommended since 2005 not siting sensitive uses within 500 feet of freeways²; the City Planning Department in 2012 adopted an advisory notice to inform property owners and developers of sites up to 1,000 feet from freeways of such health issues and provide, as a condition of approval, that the City Planning Commission could require reducing exposure to such pollutants through site design or a
