## REVISED DRAFT ORDINANCE AMENDING LOS ANGELES ADMINISTRATIVE CODE TO AUTHORIZE THE BOARD OF WATER AND POWER COMMISSIONERS TO DELEGATE AUTHORITY TO THE GENERAL MANAGER TO PURCHASE NATURAL GAS IN EXCESS OF EXISTING PRICE LIMITS WITHIN DESCRIBED PARAMETERS WHEN NECESSARY TO PROVIDE A RELIABLE POWER SUPPLY TO RETAIL CUSTOMERS AT THE LEAST COST

Honorable Members:

This Office has prepared and now transmits for your consideration the enclosed revised draft ordinance, approved as to form and legality. This Office previously transmitted the original draft ordinance which would amend Los Angeles Administrative Code (LAAC) Section 10.1.1, Subsection (b), to authorize the Board of Water and Power Commissioners (Board) to delegate authority to the General Manager to purchase natural gas in excess of existing price limits within described parameters when necessary to provide a reliable power supply to retail customers at the least cost. At the Energy and Environment Committee held on October 7, 2015, the Ratepayer Advocate of the Office of Public Accountability requested that the draft ordinance include the notification process found in LADWP Board Resolution No. 016 044. The Chair of the committee was amenable to the request. Therefore, this revised draft ordinance is submitted with the requested modification for consideration.

## **CEQA Findings**

In accordance with Section 15060 (c)(3) of the California Environmental Quality Act (CEQA) Guidelines, an activity is not subject to CEQA if it does not meet the definition of a project. Section 15378 (b)(5) states that organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment do not meet that definition. Therefore, the recommendation of the proposed ordinance related to the cost of natural gas is not subject to CEQA.
