

## MOTION

I MOVE that the matter of the Homelessness and Poverty Committee Report relative to the City's Comprehensive Homeless Strategy, Item No. 6 on today's Council agenda (CF#15-1138-S1), BE AMENDED to:

1. Add the Mayor's Office as a Collaborating Departments/Agencies to the following Strategy Briefs as set forth below:
  - 3B – No Wrong Door- Develop Encampment Engagement Protocols;
  - 4B – Coordinated Entry System Strengthen Departmental Support for Homeless Case Managers;
  - 4C – Coordinated Entry System Strengthen CES Data Sharing and Tracking;
  - 5D – Governance Evaluate LAHSA JPA & Composition of Commission;
  - 5E – Governance Create Regional Homelessness Advisory Council; Joint County-City Implementation Group;
  - 6D – Facilities Identify Public Land for Homeless Facilities;
  - 7Q – Housing Support House LA Initiative;
  - 8A – Land Use Analyze City-Wide Zoning for Homeless Housing; and
  - 9J – Additional Strategies Social Impact Financing/Pay for Success.

    - City Administrative Officer and/or Homeless Strategy Committee to be lead along with Los Angeles Homeless Services Authority (LAHSA)
  
  - 6D - Facilities Identify Public Land for Homeless Facilities
    - LAHSA
    - Department of City Planning
    - Housing and Community and Investment Department (HCID)
    - Mayor's Office of Innovation
  
  - 7N – Housing Evaluate Youth Housing Needs
    - Philanthropic Organizations (i.e. Hilton Foundation)


