#### RECOMMENDATION

That the Council, authorize the Chief of Police, or his designee, to negotiate and execute a First Amendment to Contract No. C-126467 with LexisNexis Claims Solutions, Inc. for the purpose of adding \$35,000 for enhancements to the Community Online Reporting Service (CORS) and the Report Distribution Service (RDS), subject to the review and approval of the City Attorney as to form.

#### **BACKGROUND**

On October 14, 2015, the Council approved a five-year contract with LexisNexis Claims Solutions, Inc. for the purpose of developing a CORS and RDS which facilitates the efficient reporting of incidents by the public that do not require involvement of a Police Officer and the electronic retrieval of traffic collision reports requested by the public and insurance companies. Both of these systems have been implemented and are reported by the Department to be functioning as planned. To date, 3,177 reports have been submitted through CORS, including 583 for vandalism, 109 for harassing phone calls, and 2,485 for lost property, while 37,386 traffic reports have been purchased through the RDS.

The First Amendment would add \$35,000 for the costs of programming three necessary modifications to the CORS system, which was purchased as a commercial off-the-shelf application without significant Department customizations in order to keep system costs low. Since the annual contract compensation of \$60,000 covers licensing and maintenance fees only. the proposed modifications are an added cost to the contract. These modifications will improve the user experience for residents, reduce the review time for vandalism reports, and improve the Department's tracking of crime locations. Specifically, the Amendment will provide the following reporting enhancements:

- Limiting vandalism (property and vehicles) report filing to crimes with less than \$400 in damages since these reports do not require a Police Officer to take the report. As there is not currently a dollar limit programmed into CORS for vandalism reports, residents sometimes use CORS to file reports with damages above \$400, requiring follow up by a Police Officer and the additional time of residents:
- Automatically assigning Reporting District and Geographic Area data to crime reports submitted through CORS to allow for improved crime location tracking; and,
- Automatically limiting the city field auto-population options based on other address fields
  provided by the filer (e.g., zip code) thereby simplifying the filer's user experience and
  avoiding errors in location data.

#### FISCAL IMPACT STATEMENT

No additional General Fund appropriation is required as the Department's operating budget will provide funding for the First Amendment (\$35,000) to this Agreement with LexisNexis Solutions, Inc. Therefore, approval of this contract Amendment complies with the City's Financial Policies in that budgeted funds are being used for one-time expenses.

# FIRST AMENDMENT TO CITY CONTRACT NO. C-126467 BETWEEN THE CITY OF LOS ANGELES AND LEXISNEXIS CLAIMS SOLUTIONS INC.

This **FIRST AMENDMENT** ("First Amendment") to Los Angeles City Contract No. C-126467 (the "Agreement") is made and entered into by and between the City of Los Angeles, a municipal corporation (herein referred to as "City"), acting by and through its Police Department ("LAPD"), and LexisNexis Claims Solutions Inc., on behalf of itself and its affillates, an Arizona Corporation (herein referred to as "Contractor").

WHEREAS, the City and the Contractor have entered into Los Angeles City Contract No. C-126467 wherein Contractor agreed to provide two (2) related web-based systems allowing the public to submit selected Incident Reports and/or allow the community to request copies of select police reports through a secure application; and

WHEREAS, Section 14.1 of the Agreement provides for amendments to the Agreement; and

WHEREAS, the City and the Contractor are desirous of amending the Agreement to add a service change to Attachment B, Statement of Work, of the Agreement. The changes include limiting online filers to amounts under \$400, automatically adding reporting district and geographic areas to reports, and limiting city field auto-population options based on the other address fields provided by the filer; and

WHEREAS, this First Amendment is necessary and proper to continue and/or complete certain activities authorized under the Agreement.

NOW, THEREFORE, the City and the Contractor hereby agree that the Agreement be amended as follows:

- 1. Section 7.0, Compensation and Method of Payment
  - A. City will pay to Contractor as compensation for complete and satisfactory performance of the terms of this Agreement, an amount not to exceed Two Hundred Seventy-Five Thousand Dollars (\$275,000). Of this amount, Two Hundred Forty Thousand Dollars (\$240,000) will be used for Maintenance and support ("Annual Fee") of CORS as follows:

- F. Of the total compensation included in Section 7.0 (A) above, the City will pay the Contractor for services to be performed, and tasks to be implemented as specified in this Agreement and the attached Statement of Work (Exhibit 1) and satisfactorily performed in accordance with the terms of this Agreement, an amount not to exceed Thirty-Five Thousand Dollars (\$35,000).
- 2. Attachment B (Statement of Work) of the Agreement is hereby amended in its entirety and restated as set forth in Exhibit 1 of this First Amendment, which is attached hereto.
- 3. Except as herein amended or modified, all terms and conditions of the Agreement shall remain unchanged and in full force and effect.
- 4. This First Amendment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. This First Amendment includes three (3) pages and one (1) Exhibit, which constitute the entire understanding and agreement of the parties.

#### 1 Purpose of this Statement of Work

- Contractor and LAPD will communicate and identify suitable solutions to any critical defects identified during UAT.
- · Contractor corrects critical defects.
- LAPD performs UAT to confirm all critical defects have been corrected.
- Contractor prepared to load Enhancement 2 onto LAPD CORS Production Environment.

- Contractor prepared to load Enhancement 3 onto LAPD CORS Production Environment.

#### **CORS Production Environment**

- Contractor loads CORS Enhancement 3 on the LAPD CORS Production Environment.
- LAPD confirms that filers will be able to choose from an appropriate list of entries in the city field.

#### Acceptance Criteria:

  - LAPD CORS Production Environment is successfully rolled out with Enhancement 3 operating as exhibited on the LAPD CORS Staging Environment

- LAPD will provide an address file in CSV format containing all valid addresses in LAPD's
  jurisdiction that contains the city names followed by the GA name.
- LAPD will provide an intersection file in CSV format containing all valid intersections in LAPD's jurisdiction that contains the corresponding city names followed by the GA name.
- UAT is limited to ten (10) business days in duration, assuming all UAT issues can be resolved during this time.
- LAPD is responsible for UAT and contributing to integration testing.

#### 6 Rollout (Post Go-Live Support)

Note: Rollout for the CORS enhancements can only be conducted if the corresponding implementation phase for the CORS or RDS has been completed and accepted.

This section includes all activities, deliverables and assumptions for providing Post Go-Live support of the CORS enhancements on the LAPD CORS Production Environment:

#### Activities:

- Contractor will host CORS for the LAPD twenty-four (24) hours a day, seven (7) days a
  week, with a 99% uptime.
- Contractor will support CORS in any technical capacity necessary to ensure production functionality and provide help desk support for handling inquiries and problems.
- Contractor will provide online and toll-free telephone-based customer service for LAPD and community members between the hours of 5:00 a.m. and 5:00 p.m. (Pacific Time) and call back phone support will be provided after hours.
- Contractor will ensure the system regains operations within seventy-two (72) hours after operations were suspended due to application failure.
- Contractor will work with LAPD to resolve any issue and ensure LAPD is 100% satisfied.
- Contractor will correct any element of the system which fails to perform in accordance with
  the requirements of this Contract, at no cost to the Department. Corrective action will
  include, but is not limited to, redesigning, repairing or replacing the nonconforming element
  of the software. Ensuring the software is free from imperfections in design and free from
  any and all defects and is able to perform continuously and satisfactorily under normal
  operating conditions.
- Contractor will ensure that all maintenance is performed by qualified personnel who are familiar with the CORS system.
- Contractor will provide notification if any updates or enhancements are being made to the CORS system that will impact access to the system. Notification will be a written notice fifteen (15) days in advance to the LAPD Project Manager, advising of the change and potential impact.
- LAPD may request additional enhancements be added to CORS during the term of the
  contract. If new enhancements are requested by LAPD, then an enhancement request will
  be submitted to the Contractor via a written request to the Contractor PM. Contractor will
  evaluate the requirements of the request and provide a proposal to the LAPD PM that will
  include the cost (if any) and timeline for completing the request.
