Roybal Hearing Room 350, City Hall, 200 North Spring Street, Los Angeles, CA 90012, to consider Categorical Exemption and related California Environmental Quality Act findings and an appeal filed by Cheryl Branch from the entire determination of the Los Angeles City Planning Commission in approving a Conditional Use to permit the use, maintenance and operation of a correctional institution that provides support services for County, State and Federal parolees and inmates transitioning into society, with the addition of 15 beds, installation of a new security system, repair of damaged exterior doors and windows, upgrade the plumbing, electrical and mechanical systems and other improvements for a floor area of approximately 17,170 square feet, 140 beds (125 existing beds), outdoor recreation space and nine vehicle parking spaces, for property located at 1730 West Vernon Avenue, subject to modified Conditions of Approval.
