

CUSTOMERS LIKE MYSELF HAVE BEEN OVER-CHARGED FOR YEARS BY THE DEPARTMENT'S "40 YEAR OLD OUT-DATED BILLING SYSTEM"! (TO QUOTE FROM THE DEPARTMENT'S OWN 'MESSAGE TO CUSTOMERS' PUBLISHED RECENTLY ON THEIR WEBSITE.)

MY TYPICAL BILL IS THE BILL DATED APRIL 21 1915 FOR **325.30**.

IN A RECENT BILL DATED JULY 15 2015 THE AMOUNT JUMPED TO **1,291.28** **THREE TIMES** MY NORMAL BILL.

THE DEPT. CORRECTED IT DOWN TO **708.05** (WHICH IS THE AMOUNT I ENDED UP PAYING) BUT IT'S STILL RIDICULOUSLY HIGH WITH LITTLE OR NO LOGICAL EXPLANATION.

SPEAKING WITH VARIOUS CUSTOMER REPRESENTATIVES IS A JOKE. THAT IS, IF YOU CAN GET ONE ON THE PHONE. APPARENTLY, MANY HAVE BEEN TRAINED HURRIEDLY AND HAPHAZARDLY IN ORDER TO COMPLY WITH GROWING PUBLIC OUTRAGE WITH THE DEPARTMENT!

A RATE INCREASE AT THIS TIME IS A SLAP IN THE FACE TO THE CUSTOMERS OF LADWP.




Dear Members of the Los Angeles City Council:






