To The Honorable Members of the City Council of Los Angeles:

As homeowners in the City of Los Angeles served by the Department of Water and Power, **WE PROTEST** the Proposed Water Rate Restructure and Increases for the Los Angeles Department of Water and Power. As owners of a single family home with a yard and a fruit orchard requiring irrigation, the rates proposed in the December 2015 Notice show rates increasing from \$3.52 to as much as \$10.58 per HCF for the new proposed top tier.

We understand the necessity of investing in the upkeep of the infrastructure of our water distribution system. However, the higher salaries at the DWP compared to other City Departments and to equivalent jobs in private industry, along with inefficiencies rampant in the Department, should be addressed and adjusted before considering a rate increase forcing City residents to pay even more for these services. Furthermore, DWP rates are comparable to other water districts around California, and those water districts maintain their infrastructure with the payments received from their ratepayers.

We do, however, understand that the DWP may need to pass along the temporary increases in cost of water they purchase during the current drought. We believe that any such surcharges to the customers of the DWP should not exceed the true and actual costs of water over and above normal prices charged to the DWP.

Please do not approve this unreasonable increase in rates

Dear Members of the LA City Council:

I am the owner of record for 9515 Penfield Avenue, Chatsworth, CA 91311-5514, and I am writing to **PROTEST** the proposed restructure and increase of water rates.

The LADWP has not been managed effectively and has not explored cost-cutting strategies of its own operation before asking for this restructure and increase of rates. They need to cut the fat. Government and businesses tighten their belts when revenue declines. The LADWP should do the same.

One area is personnel. It is well known that LADWP employees are paid at higher levels than their counterparts. Further wage increases should cease and a hiring freeze instituted.

I protest the change of tiers and seasonal usage blocks. LADWP wants to remove seasonal allotments, lot size and temperature zones from the First Tier. I live in the hot San Fernando Valley, usually up to 10 degrees hotter than other parts of LA. LADWP wants to compress the high season to June through September. We had the hottest October on record in 2015 and it is likely that this warming will continue.

LADWP states the need to increase rates to invest in infrastructure. Why hasn't it be doing this all along? Pipelines that are 100 years old didn't get that old overnight. Did the LADWP expect pipes to last forever?? Customers should not have to pay for poor planning and ineffective management. Too bad we don't have a choice in utility companies.

I urge the City Council to reject the proposed water rate restructure and increases and tell the LADWP to come up with an alternate plan.
