

We protest the LADWP water rate increases and Water Rate Ordinance.


Just keep on raising at the last hard to be a few to be a the Water Rate Ordinance.





WHY WE OPPOSE THE FIVE-YEAR RATE INCREASE FOR DWP

-According to the LADWP's own benchmarking study and a review by the ratepayer advocate and an independent study, LADWP salaries and benefits are higher than comparable utilities, higher than comparable jobs for L.A. City, and higher than comparable jobs across the nation, yet nothing is being done about it except calls for more studies—while LADWP plans a "cost-of-living" raise in 2016.

-The new water rate ordinance <u>lifts the cap</u> that limits the extra charges for "adjustment factors", which raise your rates in-between the other rate increases. <u>These extra charges will now be unlimited, and they can be increased over and over, without City Council approval.</u>


