11. PUBLIC OUTREACH

LADWP has held many meetings with Neighborhood Councils (NC), the business community, the environmental community and other constituent groups to demonstrate the necessity for the restructuring and rate increases and obtain valuable feedback, which assisted in the preparation of the proposed rates that are presented to the Board.
