DISCUSSION

The donation is for the benefit of the Los Angeles Police Department (Department). Ms. Joan Brody is an independent contractor with nearly 30 years of experience working with police departments and other criminal justice agencies on public and private sector grant development and implementation. Ms. Brody is a skilled interviewer, facilitator, writer and crime analyst, as well as an expert in the field of grant development and public safety fundraising. Under the direction of Police Chief Charlie Beck, Ms. Brody proposes to continue working with the Department through the end of 2016 on three specific tasks. The first task is targeting new discretionary State and Federal funding, the second task is assisting the Department Grants Unit with acquiring new grant funding, and the third task is Assisting the Los Angeles Police Foundation on the National Institute for Justice body worn video study.

Scope of Work

Joan Brody is an independent contractor with nearly 30 years of experience working in police departments and other criminal justice agencies across the nation on public and private sector grant development and implementation tasks. Joan Brody is a skilled interviewer, facilitator, writer and crime analyst, as well as expert in the field of grant development and public safety fundraising.

Per Police Chief Beck and under his direction, Joan Brody proposes to continue working with the Los Angeles Police Department (LAPD) on the following three tasks through the end of 2016.

Task One: Target New Discretionary State and Federal Funding

Chief Beck has asked Ms. Brody to develop a set of ongoing strategies for proactively seeking additional, discretionary state, federal and private funding (working with LAPF) for priority Department areas, including, but not limited to:

Ms. Goodrich will also ask Joan Brody to continue to provide coaching and technical assistance to grant staff on designated projects throughout 2016. Ms. Brody will continue to work with the LAPD Grants

Unit, their liaison in the Deputy Mayor's Office of Homeland Security and Public Safety and the Los Angeles Police Foundation to assist in identifying, developing, and writing public grants.

Task Three: Assist the LAPF on the NIJ Body Worn Video Study

Joan Brody will assist Cecilia Glassman on administrative tasks associated with implementing and reporting on the U.S. Department of Justice \$2M National Institute of Justice Body Work Video evaluation project.

Deliverables

1. Consultant will brief Chief Beck and Ms. Goodrich on a quarterly basis re progress on proactive grant seeking recommendations for additional state and federal discretionary funding in the Chief's priority funding areas.
2. Consultant will develop concept papers, strategy documents and grant applications related to supporting priority initiatives and as assigned by Chief Beck, Ms. Goodrich and the LAPF during the contract period.
3. Consultant will provide written documentation on NIJ grant administrative tasks as assigned by Cecilia Glassman.

Project Staff/Biographical Sketches

Joan Brody is an independent subcontractor who works with municipal police departments across the nation to successfully obtain additional public and private funding and resources. Ms. Brody is a skilled fundraiser who has developed a methodology to enhance grant development efforts in public sector agencies by assessing their needs and working with them to develop a strategic plan for acquiring additional grant dollars.
