DISCUSSION

The donation is for the benefit of Metropolitan Division's K9 Platoon and the Los Angeles Police Department (Department). The donation will be used to procure equipment and training to increase the level of care and longevity of City-owned Police Service Dogs (PSDs). This will increase the K9 Platoon's ability to support Department operations by providing well-trained PSDs to effectively search for suspects and/or firearms, while enhancing officer safety and providing outstanding service to the community. Metropolitan Division has a restricted account with the Los Angeles Police Foundation (Foundation). The Foundation will use funds from this account to pay for the necessary care and maintenance of the PSDs.
