PUBLIC SAFETY COMMITTEE REPORT relative to the donation of Morale and well-being items and special events for the benefit of sworn and civilian members of the Los Angeles Police Department (LAPD).

Recommendation for Council action:

ACCEPT the donation of Morale and well-being items and special events, valued at \$40,000, from the Los Angeles Police Foundation, for the benefit of sworn and civilian members of the LAPD; and, THANK the donor for this generous donation.

Fiscal Impact Statement: None submitted by the Board of Police Commissioners. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

In a report to the Board dated February 14, 2018, attached to the Council file, the LAPD recommends that the Board approve the donation of Morale and well-being items and special events from the Los Angeles Police Foundation for the benefit of sworn and civilian members of the LAPD. The LAPD reports that the donation will be used for events and equipment which directly promote the morale and well-being of the Department's 13,000 employees. Funds will be used to purchase items not covered by or limited under the City's budget, as well as to offset the costs for the Military Liaison Program, Behavioral Sciences Section, and events such as the Reserve, Civilian, and Holiday assembly functions. At the meeting held on April 11, 2018, your Public Safety Committee considered this matter. After an opportunity for public comment was held, the Committee recommended that Council approve the donation of Morale and well-being items and special events for the benefit of sworn and civilian members of the LAPD, as recommended by the Board, as detailed above. This matter is now forwarded to the Council for its consideration.
