The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Department patents.

Administrative Services Bureau has reviewed the donation and determined that it has been submitted in accordance with Section 5.467 et seq. of the Los Angeles Administrative Code, which provides for the receipt and acceptance of donations to the Department.


Currently, the Pistol Team's ammunition requirements are not supported by the Department's budget. The 89,000 rounds of ammunition are valued at \$31,098.80. No expressed or implied commitment or promise was made to the Winchester Ammunition Company in exchange for this donation. Additionally, Winchester Ammunition Company will not receive any tax advantage, preferential treatment, endorsement, recommendation, or the use of the Los Angeles Police Department patent. There is no cost to the City or the Department. Upon approval by the Department, Winchester will arrange for the donation to be delivered to Training Division (TD), at the Elysian Park Training Facility.
