DISCUSSION

The donation is for the benefit of the Los Angeles Police Department (Department) and the community it serves. Since 2015, the Department has been hosting Days of Dialogue sessions around the City to forge and foster relationships between the community and law enforcement. These sessions create a safe and constructive environment for community members and law enforcement officers to share personal experiences and opinions with the goal of continuing to build and maintain communication between the Department and the community it serves. Community Outreach and Development Division has a restricted account with the Los Angeles Police Foundation (Foundation). The Foundation will use funds from this account to pay for the expenses related to these sessions.

No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Department patents.

Administrative Services Bureau reviewed the donation and determined that the items were placed into use prior to approval by the Board of Police Commissioners. All other requirements of Los Angeles Administrative Code Section 5.467 et seq. have been met.


