The donated items will be used to replace the current inventory of 1911 pistols carried by SWAT personnel, which are past the recommended shelf life. The Uniform and Equipment Committee reviewed and approved a comprehensive product evaluation on the Sig Sauer, 1911 .45 caliber, Tac-Ops pistol. To ensure this donation is in full compliance with all municipal, state, and federal mandates, each pistol will be registered to the Los Angeles Police Department and not to a particular SWAT officer. Any future repairs will be completed by the Metropolitan Division's Armory.

No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Los Angeles Police Department (Department) patents.

The purpose of this correspondence is to seek approval and forward formal correspondence to the Honorable Board of Police Commissioners to accept an unsolicited, in-kind donation of firearms proposed by Sig Sauer manufacturing. Said donation is specific to the Department's Special Weapons and Tactics (SWAT) team, and would consist of 160 1911 Tac-Ops pistols.

On June 21, 2018, the Uniform and Equipment Committee reviewed and approved a comprehensive product evaluation on the Sig Sauer .45 caliber 1911 Tac-Ops pistol that was administered by Training Division. The Chief of Police subsequently adopted the Uniform and Equipment Committee's recommendation and approved it for all Department personnel. Although Sig Sauer is a world-renowned manufacturer of firearms, this is the first time that the Department has authorized the 1911 Tac-Ops pistol to be carried in the field.

All possible conflicts of interest have been researched, and there are no contracts between the Department and Sig Sauer. Sig Sauer representatives are fully aware that members of the Department are prohibited from endorsing any products or engaging in future commercial endeavors. Additionally, there have been no implied or expressed promises made between Sig Sauer and the Department. Acceptance of this donation coincides with the dire need to replace the current inventory of .45 caliber pistols carried by SWAT team members. Due to the ongoing budgetary constraints that prohibit replacement of the current pistol inventory, most SWAT team members are equipped with the first-generation .45 caliber pistols manufactured by Kimber.

To ensure that this donation is in full compliance with all municipal, state and federal mandates, each pistol will be registered to the Department and issued to a specific SWAT officer. It is Sig Sauer's intent to have the donated pistols registered to the Department and remain in Metropolitan Division's inventory. ITEM NO. 1 – REQUEST APPROVAL OF GLOCK M AND GLOCK GENERATION 5 HANDGUNS

After extensive testing by Training Division, Firearms and Tactics Section (FTS), it is recommended the Department authorize the Glock M series and Generation 5 series for use by Department personnel on and off duty. The Glock M and Generation 5 handguns should be approved in all the same models and calibers of the Generation 3 and 4 Glock handguns that are currently approved. Glock has manufactured its handguns in a variety of colors over the years. Some of the available colors include olive green, desert tan, Tiffany blue and grey. To avoid conflicts with color coding system and preserve a professional uniform appearance, Training Division recommends only black colored Glocks continue to be approved.

All members of the Committee unanimously recommend approving all the above items.

ITEM NO. 2 – REQUEST APPROVAL OF SMITH & WESSON MILITARY AND POLICE (M&P) 2.9 HANDGUNS

Training Division FTS recommends the Smith and Wesson M&P 2.0 be approved for use by Department personnel on and off duty. The Smith and Wesson M&P 2.0 should be approved per the current standards used for the same models and calibers of the Smith and Wesson M&P handguns. It is recommended the M&P 2.0 compact be approved in both the 3.6" and 4" barrel length model. It is also recommended that the Smith and Wesson M&P 2.0 9MM full size handgun replace the current Department issued M&P 9MM handgun. Smith and Wesson has manufactured its handguns in several colors, other than black, including desert tan. The Department currently authorizes only black Smith and Wesson M&P handguns in accordance with the firearms color coding system. Although the optional purchase 1911 program permits the use of dark green and light brown handguns, Training Division recommends that only black colored M&Ps be approved for duty use to avoid conflicts with the color coding system and preserve a professional uniform appearance.

All members of the Committee unanimously recommend approval of all the above recommendations for this item.

ITEM NO. 3 - REQUEST APPROVAL OF 1911 AND 2011 MODEL HANDGUNS

Training Division FTS personnel completed exhaustive testing of Dan Wesson, SIG, STI, and Wilson Combat 1911 and 2011 handguns. The test and evaluation cadre recommend that all handguns manufactured by Dan Wesson and Wilson Combat that meet the Departments specifications regarding single action pistols be authorized. The cadre also recommends that all STI 9MM and SIG .45 caliber designs that meet the Department's specifications regarding single action pistols be authorized. Due to the number of malfunctions experienced with the SIG 9MM test gun, the test and evaluation cadre recommends that 9MM SIG 1911 not be approved for use by Department personnel. Since the STI 2011 is a double stack design, and Dan Wesson and Wilson Combat also have double stack designs, Training Division shall update the 1911 specifications to accommodate double stack 1911 and 2011 designs for all approved manufacturers.

RE: PROPOSED DONATION OF 1911 PISTOLS BY SIG SAUER

Captain Tippet,

It has been brought to our attention that Sig Sauer would like to make a sizeable donation of its 1911, Tac Ops pistol to the Department's Special Weapons and Tactics (SWAT) team. Specifically, Sig Sauer would like to outfit the entire platoon with their pistol that recently passed an arduous product evaluation administered by Training Division. Sig Sauer has a long history of supporting law enforcement, as well as military units in the past with either donations of equipment or money.

On June 21, 2018, the Uniform and Equipment Committee reviewed and approved a comprehensive product evaluation on the Sig Sauer, 1911.45 caliber, Tac Ops pistol. The Chief of Police subsequently adopted the Uniform and Equipment Committee's recommendation and approved it for all Department personnel (attached). Although Sig Sauer is a world-renowned manufacturer of firearms, this is the first time that the Department has authorized its 1911 to be carried in the field.

The current inventory of 1911 pistols carried by SWAT personnel are first generation manufactured by Kimber. The majority are past the recommended shelf life due to age, as well as number of rounds fired. Additionally, Kimber's customer support has waned over the years for a variety of reasons. If approved, this would be a significant donation that is also timely due to Metropolitan Division's limited budget. To ensure that this donation is in full compliance with all municipal, state, and federal mandates, each pistol would be registered to the Los Angeles Police Department and not to a particular SWAT officer. It is not Sig Sauer's intent to have the donated pistols sold or registered to individual members of the team to ensure that they remain within Metropolitan Division's inventory. Sig Sauer fully understands that members of the Department are prohibited from endorsing any products or engaging in commercial endeavors to promote its firearms. There have been no implied or expressed promises made, and a complete list of Sig Sauer's past generosity is available upon request.

We would like to seize this opportunity, and move forward with preparing the requisite correspondence to present to the Honorable Board of Police Commissioners for approval.

Formal correspondence, via 15.2, with additional information will be forwarded up the chain of command if approved.


