DISCUSSION

The donation is for the benefit of the Los Angeles Police Department (Department). The Department's "Connected Officer" initiative is placing the full power of the Internet and mobility into the hands of officers in the field. The Department will be developing mobile apps and creating a Department app store that will help officers in their daily jobs, as well as giving officers access to the cloud and available mobile tools. The donation will be used to provide mobile devices and connectivity to 860 officers in the field to increase field efficiencies. Per the Los Angeles Police Foundation, this is an in-kind donation of items from Sprint for the "Connected Officer" initiative. Sprint is also a city contractor.

No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Department patents.

Administrative Services Bureau has reviewed the donation and determined that it has been submitted in accordance with Section 5.467 et seq. of the Los Angeles Administrative Code, which provides for the receipt and acceptance of donations to the Department.

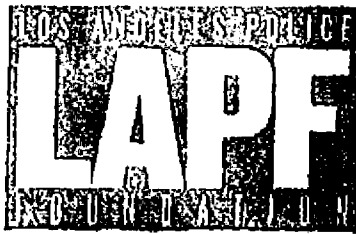
