DISCUSSION

The donation is for the benefit of Metropolitan Division's K9 Platoon and the Los Angeles Police Department (Department). The items will be used for the care and maintenance of Police Service Dogs (PSDs). This will greatly enhance the K9 Platoon's ability to supply well-trained PSDs to support Department operations while enhancing officer safety and providing outstanding service to the community.

No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Department patents.

Administrative Services Bureau reviewed the donation and determined that a portion of it was placed into use prior to approval by the Board of Police Commissioners. Metropolitan Division (Metro) admitted this was due to a clerical error on their part regarding submission of the donation. Upon discovery of the error, Metro brought it to the attention of the Chief of Police


The Los Angeles Police Foundation has restricted funding for this request. All possible conflicts of interest have been researched with negative results.
