

RESOLUTION TO VACATE NO. 18-1401269
(California Streets and Highways
Code Sections 8324, 8325 and 8340)

Vacation of 116th Street from Judah Avenue to approximately 200 feet westerly thereof.

On May 31, 2017, the City Council considered the evidence submitted regarding said vacation and determined that said street should be vacated subject to the reservations and exceptions as contemplated and subject to the conditions of vacation having been complied with, (CF 16-0041). All conditions of the Council's action have been fulfilled.

Therefore, from all of the evidence submitted, the Council finds that 116th Street from Judah Avenue to approximately 200 feet westerly thereof proposed for vacation is unnecessary for present or prospective public street purposes; and

The particular portion of the public street which is to be vacated is described herein attached Exhibits 'A' and 'B'.

RESERVING AND EXCEPTING THEREFROM, an easement to the City of Los Angeles for public sanitary sewer purposes over the entire area described hereinabove.

ALSO, RESERVING AND EXCEPTING THEREFROM, an easement for public utility facilities for the use of Southern California Gas Company, over the entire area described hereinabove.

ALSO, RESERVING AND EXCEPTING THEREFROM, an easement for sanitary sewer purposes for the use of the Los Angeles County Sanitation District, over the entire area described herein attached Exhibit "A-1" and "B-1".

ALSO, RESERVING AND EXCEPTING THEREFROM, an easement for storm drain purposes for the use of the Los Angeles County Flood Control District, over the entire area described herein attached Exhibit "A-2" and "B-2".

ALSO, RESERVING AND EXCEPTING THEREFROM, an easement for the use of the City of Los Angeles, for public pedestrian walk purposes, over the entire area described herein attached Exhibit "A-3" and "B-3".

The City Clerk shall certify this Resolution and affix the City seal, and shall transmit a sealed copy of this Resolution to the Land Development and GIS Division of the Bureau of Engineering for recordation in the office of the County Recorder of Los Angeles County.

IT IS THEREFORE RESOLVED that from and after the recordation of this Resolution, the area described hereinabove is vacated, subject to the reservations and exceptions of said permanent easements.

THENCE along the north line of said tract, said line being the boundary between the City of Los Angeles and the County of Los Angeles, S89°54'15"W, a distance of 205.79 feet;

THENCE leaving said north line and said boundary, N00°00'00"E, a distance of 24.89 feet to the beginning of a non-tangent curve, concave northwesterly, having a radius of 42.00 feet, a radial to said point bears S37°59'36"E;

THENCE continuing northeasterly along said curve, an arc distance of 34.11 feet through a central angle of 46°31'56" to a reverse curve, concave easterly, having a radius of 42.00 feet;

THENCE continuing northerly along said curve, an arc distance of 6.20 feet to the northerly right of way of 116th street through a central angle of 8°27'29" to a tangent curve, concave southeasterly, having a radius of 42.00 feet;

THENCE continuing northeasterly, easterly and southeasterly along said curve and said north right of way, an arc distance of 92.68 feet through a central angle of 126°26'14" to a reverse curve, concave northeasterly, having a radius of 15.53 feet;

THENCE continuing easterly along said curve and said right of way, an arc distance of 14.45 feet through a central angle of 53°17'55";

THENCE S00°04'16"E along said right of way, a distance of 6.67 feet;

THENCE N89°54'15"E along said right of way, a distance of 134.78 feet to the beginning of a non-tangent curve, concave southeasterly, having a radius of 72.00 feet, a radial to said point bears N33°11'15"W;

THENCE continuing southwesterly along said curve, an arc distance of 71.17 feet through a central angle of 56°38'14" to THE POINT OF BEGINNING.

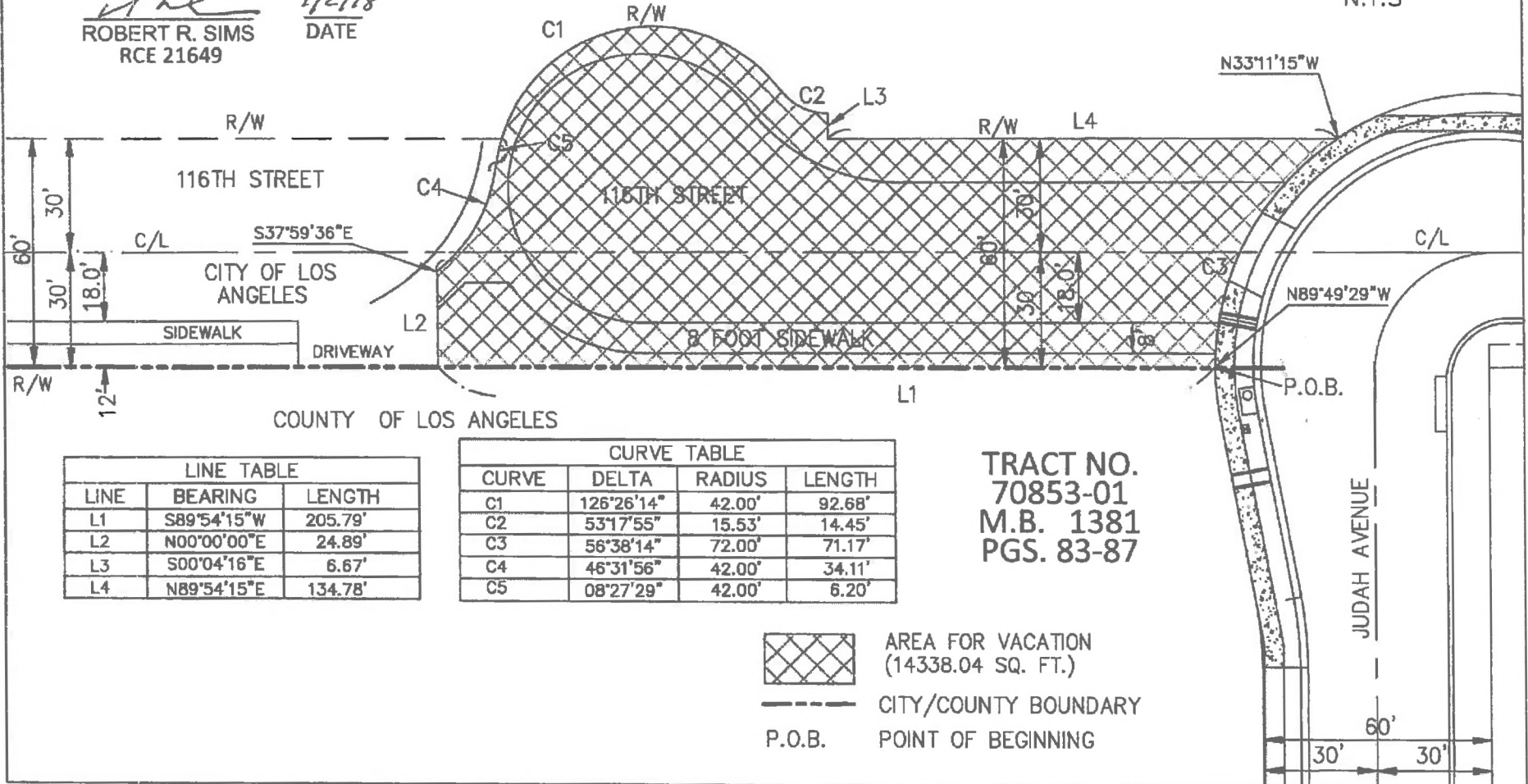

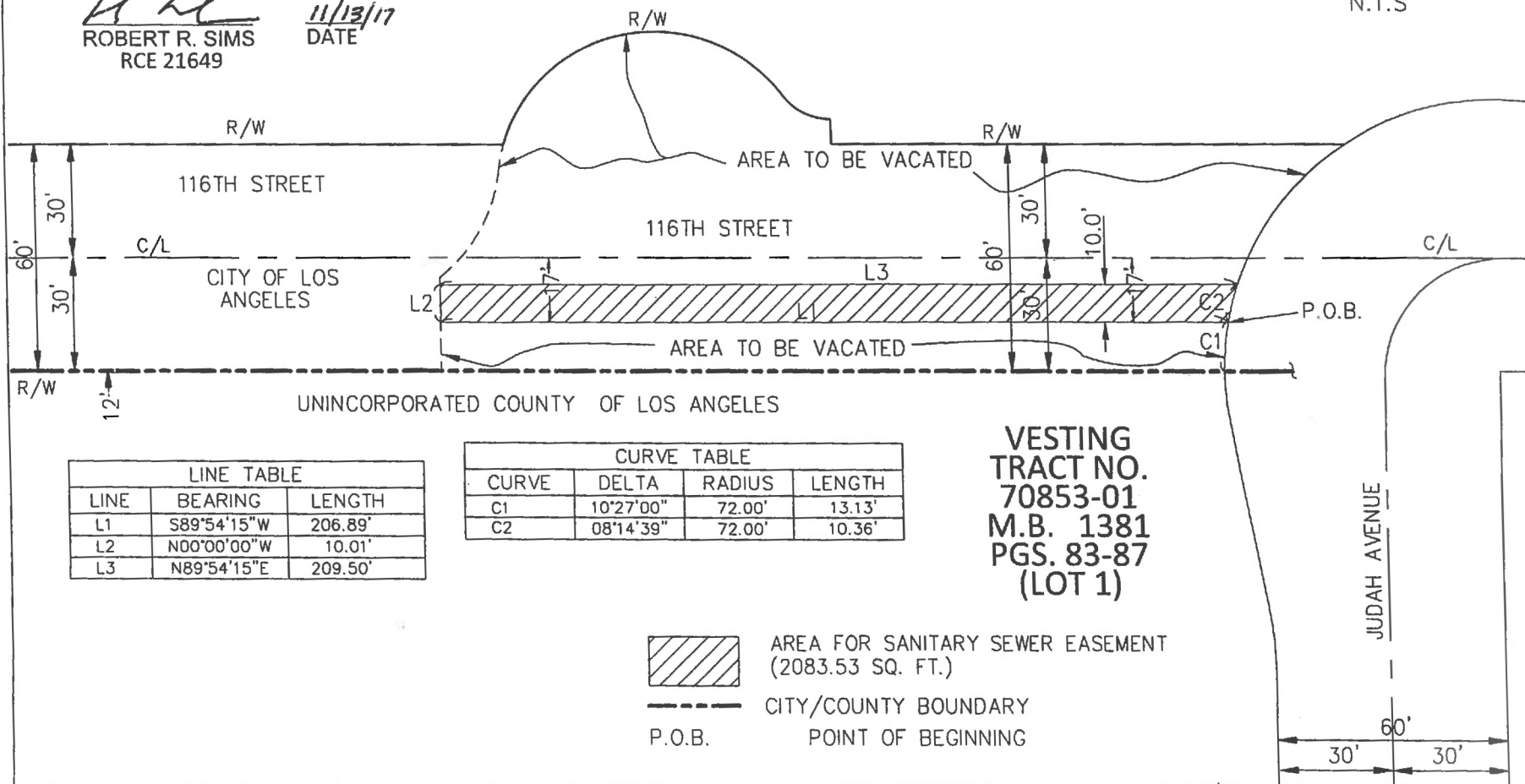
10' SANITARY SEWER EASEMENT RESERVATION PLAN S-1537

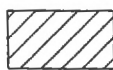

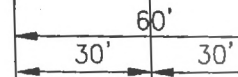

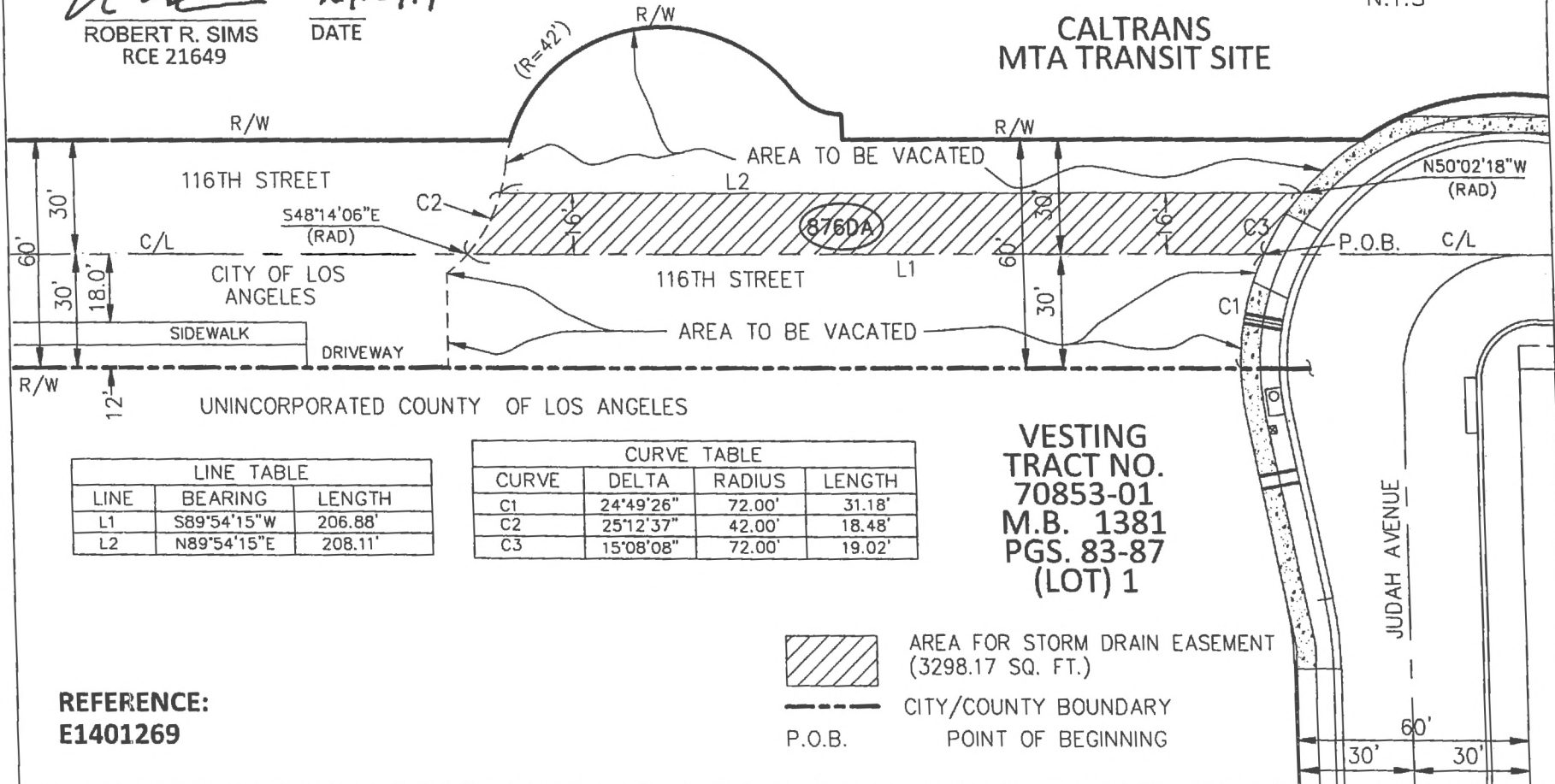

THENCE along the north line of said tract, said line being the boundary between the City of Los Angeles and the County of Los Angeles, S89°54'15"W, a distance of 205.79 feet;
THENCE leaving said north line and said boundary, N00°00'00"E, a distance of 14.82 feet to the TRUE POINT OF BEGINNING (T.P.O.B);

THENCE N00°00'00"E, a distance of 10.07 feet to the beginning of a non-tangent curve, concave northwesterly, having a radius of 42.00 feet; a radial to said point bears S37°59'34"E;

THENCE continuing northeasterly along said curve, an arc distance of 7.60 feet through a central angle of 10°22'04" to the centerline of former 116th street;

THENCE easterly along the centerline of former 116th street, N89°54'15"E, a distance of 17.78 feet to the point where the centerline of former 116th street intersects the curb face of the cul-de-sac, said point being the beginning of a non-tangent curve, concave northeasterly, having a radius of 35.50 feet; a radial to said point bears S61°25'51"W;

THENCE continuing southeasterly along said curve, an arc distance of 36.50 feet through a central angle of 58°54'35" to a point, distant 12.00 feet north of the north line of said tract and said county boundary;

THENCE easterly parallel with the north line of said tract and said county boundary, N89°54'15"E, a distance of 153.67 feet to the sideline of the knuckle on Judah Avenue, said point being the beginning of a non-tangent curve, concave easterly, having a radius of 72.00 feet; a radial to said point bears N81°34'23"W;

THENCE continuing southeasterly along said curve, being the said sideline, an arc distance of 8.05 feet through a central angle of 06°24'22";

THENCE westerly parallel with the centerline of former 116th street and north line of said tract, N89°54'15"E, a distance of 152.73 feet to the beginning of a tangent curve, concave northeasterly, having a radius of 45.50 feet;

THENCE continuing northwesterly along said curve, an arc distance of 40.12 feet through a central angle of 50°31'16";



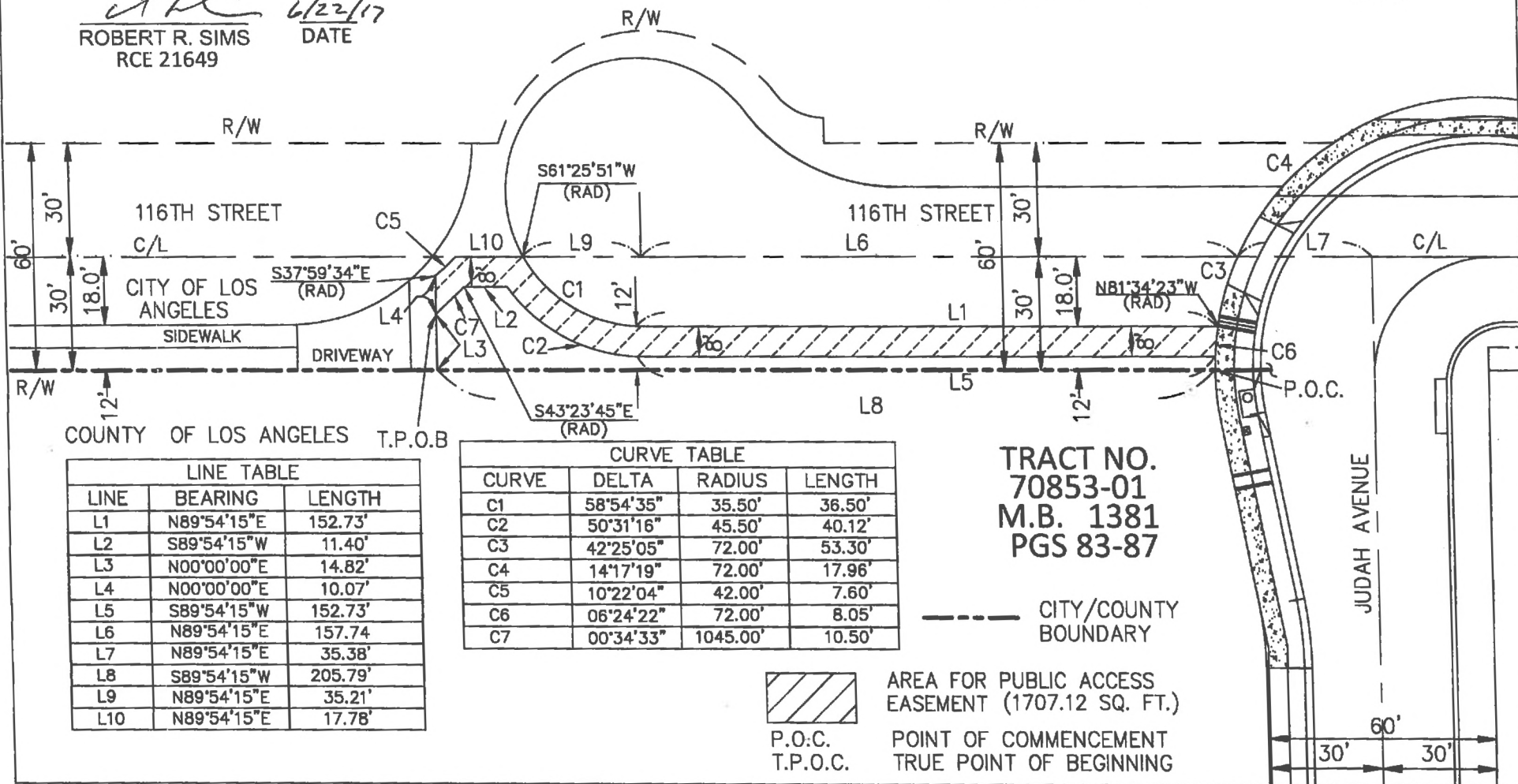
