EXEMPTION, PLANNING AND LAND USE MANAGEMENT (PLUM) COMMITTEE REPORT, and ORDINANCE FIRST CONSIDERATION relative to amending the Los Angeles Administrative Code (LAAC) to clarify Historic-Cultural Monument designation processes.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. FIND, that the provisions of the Ordinance do not constitute a project under California Environmental Quality Act (CEQA) Guidelines Section 15378, and pursuant to CEQA Guidelines Section 15378(b)(5), a project does not include organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment.
2. PRESENT and ADOPT the accompanying ORDINANCE, dated January 26, 2018, amending Section 22.171 of the LAAC to clarify Historic-Cultural Monument designation criteria, enhance due process and notification procedures affecting property owners, and provide for extensions of time limits.
3. NOT PRESENT and ORDER FILED the Ordinance dated May 12, 2017.

Fiscal Impact Statement: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

At a regular meeting held on February 27, 2018, the PLUM Committee considered a draft Ordinance relative to amending Section 22.171 of the LAAC to clarify Historic-Cultural Monument designation processes. Staff from the Department of City Planning provide background information on the Ordinance. After an opportunity for public comment, the Committee recommended to approve the draft Ordinance. This matter is now submitted to the Council for consideration.
