Subject: Authorizes execution of Amended and Restated Optical Fiber Lease Agreement No. FO-625-05/2010 (Master) and Short Form IRU-01 Lease Agreement No. FO-626-05/2010 (IRU-01) with Level 3 Communications, LLC for Lease of Los Angeles Department of Water and Power Optical Fibers. The Amended and Restated Master Agreement will extend the term for an additional 15 years or up to August 2, 2030, and Amended and Restated IRU-01 will further generate \$620,495 if the full extended term is realized.
