Attached please find letter from the Los Feliz Improvement Association for your consideration. The body of the letter is as follows

The Los Feliz Improvement Association represents 856 households and celebrates its Centennial this year.

During the lengthy process of providing input to the previous Hollywood Community Plan, the Los Feliz Improvement Association, joined with the Greater Griffith Park Neighborhood Council (now Los Feliz NC) to extensively review and comment on proposed zoning and land use changes. This effort required countless hours of dedication and diligence and resulted in a plan for Los Feliz that was approved and was included in the Hollywood Community Plan.

We oppose any changes to the existing plan in Los Feliz especially zone changes and increases to FAR, height and zoning for commercial properties along Vermont, Hillhurst, Hyperion, Hollywood Blvd and Rowena. All commercial properties should be zoned "Neighborhood Commercial" and not "Highway Oriented Commercial." The intent of the Los Feliz community is the encouragement and support for smaller, neighborhood oriented businesses.

We support retaining provisions relating to Los Feliz that were included in the former plan that was submitted and approved by the city and then, due to factors not necessarily related to our community, rejected by the court.

We respectfully request your support of these issues that are crucial to the quality of life and economic wellbeing of our community.
