Council File 16-0243 summary

Recognizing the importance of dealing with climate change the City of Los Angeles has taken steps to reduce greenhouse gas emissions. The most significant of these will be the elimination of coal-fired power plants from the Department of Water and Power's electricity portfolio by 2025.

The remaining energy portfolio will be extremely reliant on another source of greenhouse gasses, natural gas, and will also be susceptible to the price and supply constraints of the gas market. Being able to add increasing amounts of renewable energy to the portfolio has been made possible by improvements in energy storage technology and distribution grid resilience.

The need to make significant upgrades to the existing 100-year-old power system gives the city an opportunity to re-create its utility in a way that recognizes the potential for a fossil-fuel free future, demonstrates global leadership in its commitment to clean energy, and protects ratepayers from the increasing costs of carbon-based fuels. Acting on this opportunity, the City Council requested the Los Angeles Department of Water and Power to commission a study in order to determine what investments should be made to achieve a 100% renewable energy portfolio.
