

Re: Palladium Residences Off-Site Alcohol Consumption Permit Request Proposed Finding of Public Convenience and Necessity for Alcohol CF-0252, CPC-2014-3808-GPA-ZC-HD-CU-CUB-ZAI-SPR, VTT-72213, ENV-2013-1938-EIR – AGENDA ITEM #2

Dear Hon. President Wesson and Los Angeles City Councilmembers:

I. INTRODUCTION.

This firm and the undersigned represent AIDS Healthcare Foundation. Please keep this office on the list of interested persons to receive timely notice of all hearings and determinations related to the Palladium Residences Project ("Project"). We hereby adopt and incorporate by reference all Project objections raised during the environmental review process, tract map process, and City Planning Commission land use entitlement process, including all objections and evidence submitted by all other appellants in these proceedings.

II. <u>THE FINDING OF PUBLIC CONVENIENCE AND NECESSITY IS A</u> DISCRETIONARY DECISION AND REQUIRES CEQA COMPLIANCE.

Under California Business and Professions Code Sections 23958, the Department of Alcohol Beverage Control "**shall deny** an application for a license if issuance of that license would tend to create a law enforcement problem, or if issuance would result in or add to an undue concentration of licenses, except as provided in Section 23958.4," (Emphasis added.) Under Section 23958.4(b)(2):

"(b) Notwithstanding Section 23958, the department may issue a license as follows:

(2) With respect to any other license, if the local governing body of the area in which the applicant premises are located, or its designated subordinate officer or body, <u>determines</u> within 90 days of notification of a completed application <u>that public convenience or</u> <u>necessity would be served by the issuance</u>. The 90-day period shall commence upon receipt by the local governing body of (A) notification by the department of an application for licensure, or (B) a completed application according to local requirements, if any, whichever is later.

If the local governing body, or its designated subordinate officer or body, does not make a determination within the 90-day period, then the department may issue a license if the applicant shows the department that public convenience or necessity would be served by the issuance. In making its determination, the department shall not attribute any weight to the failure of the local governing body, or its designated subordinate officer or body, to make a determination regarding public convenience or necessity within the 90-day period." (Emphasis added.)

It is clear that the City Council is called upon to exercise discretion in order to determine that the public convenience and necessity would be served by granting an off-site license in a census tract, indeed a group of census tracts where there is an astounding over saturation of alcohol licenses for both on-site and off-site consumption, and the crime rate, for the Palladium census tract and Hollywood in general, is multiple times more severe than that found in other parts of the City.

Compliance with the California Environmental Quality Act is required because even the application states that the Project may cause a negative impact on the demand for police services. Pub. Res. Code § 21080; CEQA Guideline § 15357.

The Draft EIR for the Project failed to disclose and analyze or any significant information regard over saturation of licenses and the extremely elevated levels of crime, including alcohol and drug related crimes in the area. Instead, the applicant, assisted by City officials, has piecemealed this discretionary decision from others related to the Project. The effect of the piecemeal treatment of this discretionary decision, is to avoid Los Angeles City Council Page **3** of **6** April 19, 2016

proper environmental review of this new discretionary determination <u>within the context</u> of the whole of the Palladium Residences Project. Pub. Res. Code § 21159.27. This is a failure to proceed in accordance with law.

III. <u>THE CITY COUNCIL'S AGENDA FAILS TO GIVE NOTICE THAT</u> <u>ENVIRONMENTAL REVIEW WILL RELY UPON THE DRAFT EIR,</u> <u>EVEN THOUGH THE APPLICATION FOR THE DETERMINATION</u> <u>CITES DATA FROM THE DRAFT EIR.</u>

The proposed findings in support of the requested discretionary determination quote material found in the Draft EIR: police services, the project conditions, the project features, and the mitigation monitoring program. Despite specifically relying on such Draft EIR materials, the City Council's meeting agenda does not disclose, nor does the City propose to adopt the Project EIR in support of its discretionary decision, as it must. Accordingly, the City Council will violate the Brown Act by taking the proposed discretionary action without proper notice to the public that it is relying upon the Palladium Project EIR as part of its decision making process.

IV. THE APPLICANT HAS OFFERED NO EVIDENCE FOR PUBLIC CONVENIENCE AND NECESSITY TO JUSTIFY ITS REQUEST FOR ALCOHOL SALES IN A REPORTING DISTRICT OF INCREASING CRIME AND EXTREME OVERSATURATION OF LICENSES.

A. The subject area has an existing undue concentration of alcohol licenses.

The Project site is located in Census Tract 1910. The ABC allows 3 on-site and 2 off-site licenses for this Census Tract and 33 licenses already exist. There are 4 existing retailers in Census Tract 1910 that -- like Palladium's proposed Type 21 license – sell a full line of alcoholic beverages for off-site consumption: La Vida Liquor at 6007 W. Sunset Blvd.; Oligarc liquor at 6095 ½ W. Sunset Blvd.; Liquor To Go Go at 5901 Hollywood Blvd.; and Trader Joe's at 1600 N. Vine St. (Exhibit 1 – Existing overconcentration data) Census Tract 1910 therefore has an existing undue concentration of alcohol licenses for both on- and off-site consumption.

Across Sunset Blvd. from the Project site is Census Tract 1908.01, which is permitted to have three alcohol licenses (2 on-site and 1 off-site). This Census Tract has 15 existing licenses, with two retailers selling a full line of alcohol for off-site consumption (Type 21), and one with a Type 20 ABC license for the sale of beer and wine only for off-site consumption: Rite Aid at 6130 W. Sunset Blvd. (Type 21); K & L Los Angeles City Council Page **4** of **6** April 19, 2016

Wine Merchants at 1400 N. Vine St. (Type 21); and Jo Jo Market at 1356 N. Vine St. (Type 20).

Across Vine Street from the Project site is Census Tract 1907. This Census Tract is also full in regards to its permitted number of alcohol licenses, with 59 active licenses while the ABC authorizes 5 total alcohol licenses (3 on-site and 2 off-site). The off-site licenses are: Spirit Shop & Deli at 6443 W. Sunset Blvd., Type 21; Rite Aid at 6726 W. Sunset Blvd., Type 21; and Walgreen's at 1501 N. Vine St., Type 21.

To the west is Census Tract 1902.01, which is permitted to have 2 on-site licenses and 1 off-site license. Census Tract 1902.01 has 24 active alcohol licenses, including 3 Type 21 licenses for the sale of a full line of alcoholic beverages for off-site consumption: CVS Pharmacy at 1747 N. Cahuenga Blvd.; Playboy Liquor at 6435 Yucca St.; and Yucca Supermarket at 1815 N. Cahuenga Blvd.

The area surrounding the proposed Project is therefore saturated with venues selling alcohol. Within close proximity of the project location there already exist 12 retailers offering a full line of alcoholic beverages for off-site consumption.

B. The subject Reporting District has an extremely high crime rate.

The Project site is located in LAPD Crime Reporting District 647. The applicant's proposed findings deceptively state at page D-2 that RD 647 had a total of 643 arrests in 2014, but fails to reveal that citywide crime totals (known as the "ABC Runs") are based on the combined arrests and <u>reported</u> crimes for a reporting district, referred to as Part 1 and Part II crimes. RD 647 had 250 Part I crimes and 643 Part II arrests in 2014 for a total 893 crimes, compared to the citywide average of 163 Part I and Part II crimes and arrests, and the high crime reporting district average of 196 Part I and Part II crimes and arrests for the same period. In other words, RD 647 had a 2014 crime rate 547% greater than the citywide average. As acknowledged in the application, many of the Part I and Part II crimes and arrests were for alcohol and drug activity. Petitioner incorporates by reference all Crime Reporting District information for the City including District 647 which is readily available to the City and its Police Department.

The high crime rate for the project site is particularly troubling since citywide reporting districts have seen a significant reduction in crime in the past five years, while the project site has conversely experienced a crime increase. Los Angeles City Council Page **5** of **6** April 19, 2016

RD 647 had a total of 670 Part I and Part II crimes and arrests in the year 2010. Los Angeles' 1,135 Reporting Districts reported 266,457 offenses and arrests for 2010, an average of 235 crimes and arrests per Reporting District. The Project's Reporting District therefore had a 2010 crime rate just under three times the citywide average, and has therefore nearly doubled in just five years.

C. <u>The LAPD Vice Unit representative claimed he had not received notice</u> of this application.

Recently, Neighborhood Council representative Doug Haines contacted the Hollywood Police Department Vice Squad to inquire about the position of the LAPD. The Vice Officer indicated that he has had no notice of the hearing and was unaware of the application. While the record may show notice was sent to Chief Beck, there is no showing that the notice to LAPD reached the proper personnel who would review and comment on this proposal to add another off-site license in this over-saturated area.

D. <u>The City cannot make the required finding of public convenience and</u> <u>necessity.</u>

The application fails to disclose to the City what particular spaces of the Palladium Project are proposed to receive an outlet selling a full line of liquor from 11:00 a.m. to 2:00 a.m. According to the Draft EIR, the potential retail sites are in existing storefront along the Sunset frontage of the existing Palladium Night Club, and retail spaces might be located along the frontage of El Centro or Selma Avenue which is in a direct line between the exit of the Palladium Nightclub and Hollywood Boulevard where the Metro Rail and Rapid Buses run. Essentially, the applicant seeks carte blanche to sell a full line of liquor (despite the deceptive assertion the operator "might" be a boutique wine shop) right outside the Palladium dance club exits until 2:00 a.m. While one would want to hope that patrons of the Palladium would always conduct themselves responsibly following concerts, selling a full line of alcohol is patently irresponsible.

Additionally, the proposal to allow a full line of liquor sales outlet at the Palladium will directly compete with an existing free standing store nearby. The applicant attempts to distinguish the Palladium liquor outlet as "non-competing" because it is part of a larger integrated project. This is not a distinguishing characteristic. In fact, it is merely an admission that the proposed determination of public convenience and necessity is an element of the whole project – and therefore it is an admission of unlawful piecemealing of the project entitlements to avoid environmental review when such a use is incorporated into a larger project.

Additionally, the application lists two schools and other sensitive uses which are close-by, and the project itself will place residences in immediate proximity (100 feet or less) to the off-site alcohol license.

V. <u>CONCLUSION.</u>

State law regulates the issuance of alcohol licenses. Under the California Business and Professions Code, the ABC shall deny an application for an alcohol license for the following reasons, unless a determination is made that the license is necessary for public convenience and necessity:

• The premises are located within 1,000 feet of schools and playgrounds, or located in the immediate vicinity of churches and hospitals;

• The premises are located in a crime-reporting district that has a 20 percent greater number of reported crimes than the citywide average;

• The granting of the license would exceed the number of permitted alcohol licenses for the area, resulting in an undue concentration of alcohol permits;

• The premises are located within 100 feet of a residence, as measured by airline at the parking lot.

The proposal for the Palladium Residence Project to inject another off-site alcohol license in an area with extremely elevated crimes rates, and oversaturation of off-site licenses not only in the census tract, but in all of the surrounding census tracts, is not supported by the full record which the applicant has failed to disclose to the City Council. For all of the foregoing reasons, the City Council may not proceed to make the discretionary determination of public convenience and necessity, particularly on this record.
