

## MOTION

Voter approval of the July 1, 2000, City Charter established, among other things, a Citywide System of Neighborhood Councils.

The City Clerk, as provided in Section 901 of City Charter, sets forth the duties and responsibilities to assist Neighborhood Councils to share resources, including offices, equipment and other forms of support to communicate with constituents, other Neighborhood Councils and with government officials.

The above responsibilities include ensuring that Neighborhood Councils have adequate office and meeting space to conduct their business by facilitating the shared utilization of City owned or leased space, coordinating the acceptance and use of donated office and/or meeting space from private donors, as well as securing suitable office and meeting space on behalf of certified Neighborhood Councils.

On an annual basis, the City Clerk coordinates the acceptance and use of donated office and meeting space from private owners on behalf of the Neighborhood Councils. Use of donated office and/or meeting space is for this purpose only and without further conditions of use.

**I THEREFORE MOVE** that the City Council accept on behalf of various Neighborhood Councils donated office and/or meeting space from private donors for Fiscal Year 2017-18, as set forth in the attached list.
