Subject: WESSON-MARTINEZ MOTION TO REPORT ON AVAILABLE SHARED SPACES FOR USE BY NEIGHBORHOOD COUNCILS

RECOMMENDATION

That the Council, subject to the approval of the Mayor, amend the current Citywide policies and procedures for the use of space by Neighborhood Councils (NC) at City facilities, as follows:

- Amend the office space sharing agreement and increase the current 30-day written notice period to a 90-day notification period for the NC to vacate the assigned space;
- Direct the Department of General Services to notify the Municipal Facilities Committee (MFC) when a NC executes an office space sharing agreement for lease space at City facilities; and,
- Reaffirm and direct the DONE to report semiannually to the MFC, Rules, Elections, Intergovernmental Relations, and Neighborhoods Committee and any other designated Council Committee on the status of the NC Leasing program. The report will include the assignment of office space to requesting NC, the type and length of agreement and location.

SUMMARY

On March 15, 2016, Council District 10 introduced a Wesson-Martinez Motion (C.F. 16-0298) instructing the City Administrative Officer (CAO), with the assistance of the Department of General Services (GSD) and the Chief Legislative Analyst (CLA), to report on available shared spaces for use by Neighborhood Councils (NC) and the feasibility of providing NC with priority use of such spaces at City facilities. The Motion was amended in Committee to include board and committee meeting space in addition to office space. Also, the CAO was asked to report on overtime fees for the use of City facilities and the use of other governmental facility office space for NC. The CAO staff has worked with the Council Office, GSD, CLA, and the Department of Neighborhood Empowerment (DONE) to gather the necessary information.

BACKGROUND

The administrative responsibility to provide leasing services, including managing the leasing of space needed for City departments, currently rests with the GSD. On December 2, 2003, the Council, among other things, approved "Guidelines for the Acquisition of NC Office Space" and adopted a set of Citywide policies and procedures (C.F. 03-1514). On April 14, 2004, the Council unanimously approved Ordinance No. 175937 which created a streamlined process through which NC can lease office and meeting space. The Ordinance transferred the administrative responsibility for leasing and rental of office and meeting space on behalf of the NC from GSD to DONE when a standard short-term rental and lease agreement with duration of one year or less is used. The responsibility for administering agreements with a term of more than one year remains with the GSD. Currently, the GSD does not work on any NC lease agreements.

The City has a total of 96 certified NC. According to a survey conducted by DONE, 48 NC do not have office space. 48 NC do have office space as follows:

- 27 are in privately-owned space; and,
- 21 in City facilities.

The lease cost for private office space as well as one NC at a City-owned facility (Metrolink Station) totals \$176,174 annually. See Attachment One for additional detail on location and cost.

Additionally, all 96 NC have meeting space as follows:

- 36 in privately-owned space;
- 37 in City facilities;
- 14 in Los Angeles Unified School District (LAUSD) space; and,
- The balance in various combinations of facilities.

The City departments, such as Police, Fire, Airports, Water and Power, Harbor, Library and Recreation and Parks, do not charge NC fees when leasing space. However, they do charge use fees for City facilities when the space is occupied after regular hours of operation in order to recover the costs, such as staff to open and close the facility, security, custodian and maintenance services. The lease cost for meeting space totals \$47,601 annually. Of that amount, seven NC pay \$11,360 for City facilities for the cost of associated services. See Attachments Two and Three for additional detail on location and cost.

NC Acquisition Process for securing Meeting and Office Space

The DONE assists the NC to secure lease space in both City facilities and those that are privately owned, utilizing either an office space sharing agreement or a formal lease, respectively. The office space sharing agreement that is used for City-owned facilities has no expiration (i.e. open-ended) and includes a 30-day termination clause. The Office of the City Attorney advises

that this agreement is non-binding. Because it is effectively a City-leased space, the Council Office has the authority to revoke the leasing arrangement by providing 30-day written notice to the NC based on the following conditions: a) Mayor's Office, Council Office, or other City department requires the use of the space; and/or, b) NC does not adhere to the rules and guidelines as set forth in the agreement. Development and execution of the agreement is typically handled by DONE. The GSD occasionally works on an office space sharing agreement if it involves a City facility such as a constituent service center.

Based on feedback from City staff, the 30-day written notice to NC to vacate the assigned space is usually not sufficient time for a NC to secure a new lease space, obtain the necessary approvals from the appropriate parties, execute a new agreement and move into that new space. Therefore, this Office recommends that the office space sharing agreement be amended and that the 30-day written notice period is increased to a 90-day notification period for the NC to vacate the assigned space.

The lease term for space in privately-owned facilities is set at a maximum of 12 months to coincide with the City's budget cycle that follows the Fiscal Year calendar (July 1-June 30). The lease agreement is executed through DONE and the City Attorney.

Any potential use of non-City facilities, such as those owned and operated by the LAUSD, would require additional time to vet with the respective entities. Currently the use of LAUSD properties for community access to recreational amenities is negotiated on a case-by-case basis through Joint-Use agreements. City staff will report to Council on potential options for utilizing non-City facilities through a future report.

Proposed Amendment to Process relative to City facilities

The City routinely receives requests to lease space at City facilities from NC, City departments, and non-profits. When it involves a City facility such as a constituent service center, the DONE and the affected Council Office typically handles NC space requests. On occasion, the Mayor's Office, other City departments and/or GSD may become involved in the process, as appropriate. The DONE forwards to GSD a copy of the NC office space sharing agreement when the use of space at a City facility is involved. This Office agrees that decisions regarding the use of space at City facilities such as a constituent service center, regardless of the origin of the request (i.e. NC, City department, or non-profit), should continue to remain with the affected Council Office and the appropriate City department (GSD/DONE). Once GSD/DONE is notified of the proposed space request, staff should evaluate the feasibility and cost of the space and report back to the affected Council Office, the GSD/DONE should move forward with the appropriate approval process.

On December 2, 2003, the Council approved an exemption for DONE (when operating on behalf of the NC) from the administrative requirement that their space needs be submitted to the MFC for study, review or recommendation with respect to, locating City-owned, leased, or private space for occupancy or to share with other departments or offices. Instead the Council the Council directed the DONE to report semiannually to the Municipal Facilities Committee (MFC),

Education and Neighborhoods Committee (ENC) and any other designated Council Committees on the status of the NC Leasing program. The report will include the assignment of office space to requesting NC, the type and length of agreement and its location. The original Council instruction included the ENC, which no longer exists. Rules, Elections, Intergovernmental Relations, and Neighborhoods Committee (REIRNC) currently have jurisdiction over NC items. Currently, the MFC is not being notified of the assignment of office space to a NC at City facilities. Therefore, this Office recommends that Council and Mayor approve the following instructions:

- Direct the GSD to notify the MFC when a NC executes an office space sharing agreement for lease space at a City facilities; and,
- Reaffirm and direct the DONE to report semiannually to the MFC, REIRNC and any other designated Council Committee on the status of the NC Leasing program.
