SUBJECT: UNCLAIMED MONIES SEIZED INCIDENTAL TO ARREST TRUST FUND

Dear Honorable Members:

On May 20, 2016, the Los Angeles Police Department (LAPD) requested an escheatment of \$544,821.93 from the “Unclaimed Monies Seized Incidental to Arrest Trust Fund” No. 7772 (UMSIATF) to the City’s General Fund. This money has remained unclaimed for three years and is therefore eligible for transfer in accordance with the notification requirements of the City of Los Angeles Administrative Code Section 5.1112 and current state law.

BACKGROUND

The State of California Government Code Section 50050-50055 provides that any money remaining unclaimed in the City Treasury for three years or more may become the property of the City after publication of a notice, provided that within the specified period of time, no verified complaint seeking to recover all or a designated part of the money is filed in a court of competent jurisdiction.

Attached herewith is LAPD’s request to escheat monies from Fund No. 7772 dated May 20, 2016, the Office of the City Clerk’s proof of publication advertisements dated June, 23, 2016 and the subsequent notice and publications executed on June 30, 2016. These notices stated that on August 16, 2016, funds seized from April 22, 2007 through April 1, 2013 would become property of the City. As of the respective aforementioned dates, no claims have been processed. Per the City Council’s instructions (CF No. 04-2206-S1), the Office of Finance has reviewed the escheatment eligibility and publication notices.

RECOMMENDED ACTION

In accordance with the authority of the State Government Code and City of Los Angeles Administrative Code, it is recommended that City Council, subject to approval of the Mayor, should:

1. INSTRUCT the Los Angeles Police Department and the City Treasurer to process the sum of \$544,821.93 from the Unclaimed Monies Seized Incidental to Arrest Trust Fund No. 7772 (UMSIATF); and
2. REQUEST the Controller to TRANSFER all identified eligible monies to the General Fund, Fund No. 100, Department 70, Revenue Source Code 4834.




