PUBLIC SAFETY and ENTERTAINMENT AND FACILITIES COMMITTEES' REPORT relative to the fifth amendment to the existing agreement between the Los Angeles Police Department (LAPD) and RMI International Inc. for security guard services at City facilities.

Recommendation for Council action:

AUTHORIZE the Chief, LAPD, or his designee, to execute a Fifth Amendment with RMI International, Inc. (C-120938) on behalf of the City for security guard services at City facilities for a term of six months from March 1, 2016 through September 30, 2016, with annual compensation not to exceed \$10,000,000 per year, subject to available funding.

Fiscal Impact Statement: The City Administrative Officer (CAO) reports that approval of the above recommendation will authorize the LAPD to extend the contract with RMI International, Inc. for security guard services at City facilities for a term of six months at an annual cost not to exceed \$10,000,000. Execution of the proposed contract amendment is in compliance with the City's Financial Policies in that budgeted funds will be used for budgeted purposes and the City's obligation is subject to the amount appropriated for the budgeted purpose and to the availability of funding in each fiscal year.

SUMMARY

At the meeting held on April 19, 2016, your Public Safety Committee considered a CAO report relative to the fifth amendment to the existing agreement between the Los Angeles Police Department and RMI International Inc. for security guard services at City facilities. The CAO reports that the original contract was authorized for a period of one year, from September 1, 2012 to August 31, 2013, and extended for two, one-year options and again extended for two, three-month periods in order to give the LAPD time to complete a new Request for Proposals (RFP) process. RMI International, Inc. submitted a proposal in response to the RFP and was selected by the Board of Police Commissioners (Board) for a new contract with the LAPD for security guard services. The Board authorized the LAPD to negotiate this agreement with RMI International, Inc., as well as other successful bidders, on January 19, 2016 and discussions are currently underway. After an opportunity for public comment was held, the Committee moved to approve the recommendation presented in the CAO transmittal, as detailed above.

Subsequently, on May 10, 2016, your Entertainment and Facilities Committee also considered this matter and after providing an opportunity for public comment, the Entertainment and Facilities Committee concurred with the Public Safety Committee.

This matter is now forwarded to the Council for its consideration.
