An ordinance amending Chapter 5 of Division 24 of the Los Angeles Administrative Code to amend the City Ethics Commission regulations regarding the City's ticket distribution policy.

## THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. The introductory paragraph of Section 24.54 of Chapter 5 of Division 24 of the Los Angeles Administrative Code is amended by replacing "18944.1(d)" with "18944.1(f)".

- Sec. 2. Subsection (b) of Section 24.54 of Chapter 5 of Division 24 of the Los Angeles Administrative Code is amended to read as follows:
  - (b) The Ticket Administrator shall file a copy of the form with the Ethics Commission within 30 days after the ticket or pass is distributed. The Ethics Commission shall post the form on its website and notify the state's Fair Political Practices Commission of the website link where the forms are posted.

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
