Re: Sewer System Serving Properties on West Point Drive, Council District 1

Dear Mr. Zaldivar:

I am contacting your office to request that the Bureau of Sanitation review and advise my office regarding the adequacy of the sanitary sewer system serving properties on West Point Drive in the Mount Washington community in the First Council District.

West Point Drive is located in a single-family residential neighborhood with hilly topography. The pattern of development in the vicinity includes properties improved with single-family dwellings interspersed with vacant lots. Longtime vacant properties are currently proposed for development with new construction of single-family dwellings. City policy requires new construction of houses to connect with the public sewer system. Existing houses at the top of West Point Drive, however, may or may not necessarily be connected to the public sewer system; in some cases, they may be served by septic tank connections.

Local community members have observed City of Los Angeles sewer cleaner trucks traversing the hilly street in order to provide sewer cleaning and maintenance services within the public right-of-way. Given future new construction of houses on West Point Drive and in the vicinity, and the observation of the recurrence of cleaner trucks atop the hill, questions about the adequacy of the public sewer system have arisen. Therefore, my office requests the Bureau to investigate the situation and report back with your findings.

Longtime vacant properties are currently proposed for development with new construction of houses. With a future anticipated increase in vehicular usage of the roadway, the local community has expressed concern about public safety and the adequacy of the intersection design to facilitate the flow and circulation of vehicular traffic and emergency vehicle access.

According to ZIMAS and Navigate LA, each street has a 30-foot public right-of-way. The existing paved roadway appears to be an estimated 20-feet in width. As a motorist ascends West Point Drive in a northwesterly direction, he or she must currently maneuver the vehicle by making a sharp turn and switching back on to West Point Drive to further ascend in a southeasterly direction to the top of the hill.

Our office believes that existing conditions merit review by the Bureau of Engineering in the interest of protecting public safety. Toward this end, our office requests BOE to further

investigate existing conditions at this location, and report back with your findings and recommendations.
