Hope this finds you well.

I wanted to bring to your attention an irregularity in the maintenance of City Council file 16-0503. The PLUM Committee voted on August 15, 2017 to grant the appeal and refer the project back to the Planning Department for preparation of proper environmental review. Indeed, the City's Council file lists as an action: "08/15/2017 Planning and Land Use Management Committee granted appeal(s)." This is consistent with the audio recording of the vote where PLUM Committee Chair Jose Huizar stated that the CEQA appeal was granted in its entirety.

But instead of linking this action to the PLUM Committee Recommendation Report that would summarize the Committee's recommended action, and form the basis of moving the item to the full City

Council, the link in the Council File is to the April 2016 staff report that recommended denial of the appeal. Thus, the listed action is linked to the wrong document, and the right document appears to be missing.

Why is the PLUM Committee Recommendation Report, as of today, missing from the City Council File? Preparation and filing of the PLUM Committee Recommendation Report is a ministerial task of the City Clerk and/or City Legislative Analyst, yet months after the PLUM Committee action, no Recommendation Report is found in the Council File.

We object that as of today, the City Council's only and official files fail to include all reports and documents related to the actions of the City in this case.

I have copied Ms. Wolcott as well. Please place this email correspondence in the administrative record for Council File 16-0503.
