AN ORDINANCE AMENDING THE WEST ADAMS-BALDWIN HILLS-LEIMERT COMMUNITY PLAN IMPLEMENTATION OVERLAY DISTRICT TO UPDATE MAPS DEPICTING THE JEFFERSON/LA CIENEGA TRANSIT ORIENTED DISTRICT SUBAREA

Honorable Members:

Pursuant to your request, this Office has prepared and now transmits for your action the enclosed draft ordinance, approved as to form and legality, amending the West Adams-Baldwin Hills-Leimert (West Adams) Community Plan Implementation Overlay (CPIO) District (Ordinance No. 184,794) to update maps depicting the Jefferson/La Cienega Transit Oriented District (TOD) Subarea. Specifically, this draft ordinance will replace the Figure V-1 Subarea Boundary Map and the Figure V-2 Subarea Height' Map with the attached maps.

Background

On June 29, 2016, the City Council adopted the West Adams Community Plan update (Council File No. 16-0597). On March 7, 2017, the City Council adopted the zoning ordinances for the West Adams Community Plan update, including the adoption of the West Adams CPIO District Ordinance. On October 11, 2018, the City Planning Commission (CPC) voted to recommend a Height District change from MR1-1VL-CPIO to MR1-2D-CPIO for the Jefferson/La Cienega TOD Subarea of the West Adams CPIO District. The CPC also voted to recommend that the City Council amend the West Adams CPIO District for the Jefferson/La Cienega TOD Subarea.

On November 27, 2018, the Planning and Land Use Management (PLUM) Committee recommended that the City Council request the City Attorney's Office to prepare and present an ordinance amending the West Adams CPIO District (Ordinance No. 184,794), as recommended by the CPC. On December 11, 2018, the City Council adopted the PLUM Committee's recommendation.

Summary of Ordinance Provisions

The CPC's transmittal report to the City Council, dated November 14, 2018 (CPC Transmittal Report), includes the Planning Department's staff report, which provides a detailed description of the CPIO amendments effectuated by the draft ordinance. Notably, this draft ordinance amends the West Adams CPIO District by replacing Figure V-1 Subarea Boundary Map in its entirety with the attached Figure V-1 Subarea Boundary Map and by replacing Figure V-2 Subarea Height Map in its entirety with the attached Figure V-2 Subarea Height Map.

These new maps provide an updated depiction of the lots in the Jefferson/La Cienega TOD Subarea and the land use regulations and development standards that apply to each lot.

Charter Findings

Charter Section 558(b)(3) requires the City Council to make the findings required in Subsection (b)(2) of the same section; namely, whether adoption of the proposed ordinance will be in conformity with public necessity, convenience, general welfare, and good zoning practice. Charter Section 558(b)(3)(A) allows the City Council to adopt an ordinance conforming to the CPC's recommendation of approval of the draft ordinances, if the CPC recommends such approval. Similarly, Charter Section 556 requires the City Council to make findings showing that the action is in substantial conformance with the purposes, intent, and provisions of the General Plan. The City Council can either adopt the CPC's findings and recommendations as set forth in the CPC's Transmittal Report or make its own.

CEQA Determination

The CPC recommends that the City Council find, based on the independent judgment of the decision-maker, after consideration of the whole of the administrative

record, the project was assessed in EIR No. ENV-2008-478-EIR, State Clearinghouse No. 2008021013, certified on June 29, 2016, and pursuant to California Environmental Quality Act Guidelines, Sections 15162 and 15164, and as supported by the addendum dated April 2018, no major revisions are required to the EIR and no subsequent EIR or negative declaration is required for approval of the project.

If the City Council concurs, it should adopt these findings prior to or concurrent with its action on the ordinance.

A copy of the draft ordinance was sent, pursuant to Council Rule 38, to the Department of Building and Safety, with a request that all comments, if any, be presented directly to the City Council when this matter is considered.
