### REPORT RE:

DRAFT ORDINANCE AMENDING SECTIONS 5.500 AND 7.33.1 OF THE LOS ANGELES ADMINISTRATIVE CODE TO PROVIDE THAT PROCEEDS FROM THE SALE OF ANY SURPLUS PROPERTIES APPROVED BY CITY COUNCIL FOR USE IN SUPPORT OF THE CITY'S "USING PUBLIC LAND FOR AFFORDABLE AND HOMELESS HOUSING STRATEGY" SOLD DURING FISCAL YEAR 2016-2017 BE DEPOSITED INTO THE AFFORDABLE HOUSING TRUST FUND

### Honorable Members:

This Office has prepared and now transmits for your action the enclosed draft ordinance, approved to form and legality. The draft ordinance provides that the proceeds from the sale during Fiscal Year 2016-2017, of any surplus properties approved by City Council for use in support of the City's "Using Public Land for Affordable and Homeless Housing" strategy, be deposited into the Affordable Housing Trust Fund.

# Background and Summary of Ordinance Provisions

Existing law provides that 50% of the proceeds from the sale of City surplus property (except for property located in the Venice area and except for sales of property specifically addressed by separate Sections of this Code, including, but not limited to, Sections 5.121.1, 5.121.2 and 5.547) shall be deposited into Fund for the Council District in which the property is located, and 50% shall be deposited into the General Fund. As a part of your May 24, 2016, adoption of the Budget Resolution for Fiscal

Year 2016-2017, you requested this Office to prepare an ordinance to place all proceeds from the sale of any surplus properties approved by City Council for use in support of the City's Using Public Land for Affordable and Homeless Housing Strategy," sold during Fiscal Year 2016-2017, be deposited into the Affordable Housing Trust Fund, but that such a provision would sunset at the conclusion of Fiscal Year 2016-2017. The draft ordinance accomplishes Council's request.

## **CEQA Findings**

We recommend that City Council find that adoption of this ordinance is exempt from the California Environmental Quality Act (CEQA) through a General Exemption under Article 19, Categorical Exemption Section 15312 of the State CEQA Guidelines and Article II, Class 12 of the City CEQA Guidelines. If you concur, you should adopt this finding prior, to or concurrent with, taking action on this ordinance.
