

**Downtown Women's Center (DWC) Recommendations  
to the Los Angeles City Council Budget and Finance Committee  
April 25, 2016**

We are thrilled the Comprehensive Homeless Strategy (CHS) has passed, and we thank the Council for its leadership in making this unprecedented effort possible. The CHS includes two strategies focused on women – the first (**Strategy 9K**) calls for more data, research, and services for women, and the second (**Strategy 9L**) explores employment opportunities for women. Strategy 9K is among those strategies listed as priorities for 2016-2017.

**Below are two components of Strategy 9K we urge you to designate as line-item appropriations in the 2016-2017 BUDGET.**

**1. Housing Gap Analysis: \$60,000**

Women are a significant subpopulation comprising one-third of the total homeless population in the City of Los Angeles. A quarter of the homeless population is women without children or dependents, who don't have access to services available for families. We have seen with other subpopulations, such as veterans and youth, that by identifying their specific needs and meeting those needs with services, the numbers experiencing homelessness can be significantly reduced

Undertaking a Housing Gap Analysis is a critical step in reducing homelessness for one-third of the existing homeless population. An analysis of city homeless services and shelter/housing based on gender will tell us where and at what rate women are accessing services, which will help us identify likely gaps. The data will be used moving forward to help identify and reduce gaps in services and housing for women as well as provide a base measurement for evaluating programs' effectiveness in serving women.

**Administration and Cost:** Existing data sources that include gender, such as the Homeless Management Information System (HMIS) managed by LAHSA, could be used to collect and produce needed data on women. Adding the layer of gender to analyses that do not presently report by gender, such as shelter bed counts, could also be used to produce data. The cost is expected to be \$60,000, given that data can be derived from existing sources.

**2. Trauma-Informed Care Training: \$18,400**

Trauma-informed care (TIC) is a necessary standard in ensuring service providers meet women's needs in both women-only and mixed-gender settings. TIC is a service model that asks, "What happened to you?" rather than "What is wrong with you?" It acknowledges a homeless woman is likely to have experienced trauma at some point during her lifetime – 60% of DWC's population are survivors of domestic violence, 50% have experienced sexual assault, and 40% have experienced child abuse – which is compounded by the trauma of homelessness itself.

Trauma-informed care is an evidence-based practice that is effective for all individuals who have experienced the trauma of homelessness, but it is particularly effective for women, given their higher likelihood to have also survived personal violence. When used across all levels of service provision, TIC greatly improves effectiveness of emergency and permanent services, reducing costs and yielding stronger outcomes.

The City would be taking a significant step by beginning to implement TIC now, given the model's increasing traction as a best practice, similar to Housing First and Permanent Supportive Housing.

**Administration & Cost:** We recommend trauma-informed care be implemented in a number of City departments and programs that interface with individuals experiencing homelessness. These include the LAPD, Emergency Response Teams (ERTs), Navigation/Open Door Centers, and the Library. Based on a training package of two half-day sessions (\$3,000) and administration and coordination (\$1,600), the cost per department/program would be \$4,600, for a total of \$18,400. The use of a Fidelity tool would help assess the faithfulness of trauma-informed care implementation in the departments and programs, as well as assess the trainings' success.

### **BUDGET PLACEMENT**

The **Housing Gap Analysis** in the amount of \$60,000 could be included under the Data-Driven Challenge category in the proposed 2016-17 budget. The Challenge category is designated "to establish a public challenge to generate data and evidence-based strategies for providing homeless services." An analysis by gender would help generate new data and advance program effectiveness and impact. Should the Challenge category be removed as a result of budget discussions, we ask that a line item covering the Housing Gap Analysis cost be established.

The **Trauma-Informed Care Training** in the amount of \$18,400 could be split among the following proposed budget categories: Emergency Response Teams; Navigation/Open Door Centers; Library Department – Homelessness Engagement Enhancement; and Police Department – Support for Public Right-of-Way Clean Up.

Dear Councilmember Krekorian,

On behalf of the leadership of United Way of Greater Los Angeles, we are grateful for your work to effectively steward the public resources of our great City, and we stand with you in your commitment to addressing the homelessness crisis in our region. The recent progress we have made in veteran and family homelessness demonstrates that strategic investments in permanent solutions are critical in creating true progress.

The Proposed Budget for 2016-2017 propels the City of Los Angeles in this effort, and we appreciate the strong commitment to identifying resources in the immediate term. The topline funding for homelessness of \$138 million is critical to accelerating our forward momentum, and the mix of interventions that blend immediate relief and long-term solutions is vital to real impact.

We are especially pleased with the substantial increase in allocation to the Los Angeles Homeless Services Authority (LAHSA), and we would like to draw your attention to two items that we believe are needed to connect and catalyze the rest of your investments.

1. **CES Regional Coordination: Increase from \$700,000 to \$2 million**

Regional Coordination funded at \$700,000 would maintain the present level of coordination in each Service Planning Area (SPA). In order to create the linkages needed with front-line City staff and create the breadth and depth of supports to streamline the CES infrastructure, the coordination resources must be strengthened, rather than simply maintained. The following table illustrate the potential effects of this additional funding:

2. **CES Coordinated Case Management (Outreach & Housing Navigation): \$6.1 million**

This addition of CES Coordinated Case Management would provide the street to home supports that enable the proactive outreach and placement of higher-acuity persons on our streets who may not otherwise engage with our systems. Outreach and navigation services enable the community to work with these high-acuity persons to meet their immediate needs, collect the needed documents for housing, and link them to permanent housing resources. This resource would serve to significantly expand the street engagement infrastructure the City presently provides, enabling a much broader and deeper coverage of the region.

We urge you to seriously consider these two additions. The Home For Good Funders Collaborative is prepared to supplement these resources with additional private investments and will partner with LAHSA to ensure effective coordination of these public and private resources to every region of the City.
