PUBLIC SAFETY COMMITTEE REPORT relative to reprogramming funds totaling \$133,736 within the 2015 Deoxyribonucleic Acid (DNA) Capacity Enhancement and Backlog Reduction Program Grant, United States Department of Justice (DOJ).

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the Los Angeles Police Department (LAPD) to:

a. Reprogram funds totaling \$133,736 within the 2015 DNA Capacity Enhancement and Backlog Reduction Program Grant, DOJ, as follows:

Fiscal Impact Statement: The CAO reports that approval of the above recommendations will allow the reprogramming of funds of the 2015 DNA Capacity Enhancement and Backlog Reduction Program grant from the United States Department of Justice, Office of Justice Programs, National Institute of Justice for the amount of \$133,736. Approval of the above recommendations will have no impact to the General Fund. Acceptance of the grant is in compliance with the City's Financial Policies in that grant funds are sufficient to support the grant activities.
