

**AMENDMENT NO. 2 TO CONTRACT NO. 47289-5  
BETWEEN  
THE CITY OF LOS ANGELES DEPARTMENT OF WATER AND POWER  
AND  
WATERCOURSE ENGINEERING, INC.**

Amendment No. 2 to Contract No. 47289-5 is made and entered into by and between the Los Angeles Department of Water and Power (LADWP) acting by and through the Board of Water and Power Commissioners (Board) and Watercourse Engineering, Inc. (Watercourse), hereinafter referred to as "Contractor", and collectively referred to as "Parties."

Whereas, effective December 1, 2013, LADWP entered into Contract No. 49207-4, for Contractor to provide professional services for the Water Operations Division of LADWP; and

Whereas, effective December 16, 2014, Contract No. 49207-4 was amended and renumbered to Contract No. 47289-5, for Contractor to continue developing and modifying the eSTREAM modeling tool for analyzing operational scenarios and long-term planning of the Mono Basin; and

Whereas, Amendment No. 2 is necessary and proper for Contractor to further develop and modify the eSTREAM modeling tool for use in preparation of the Mono Basin Operations Plan (MBOP) and continued long-term planning and operations of Mono Basin as authorized under Contract.

Now, therefore, the Parties hereby agree to amend Contract as follows:

1. Increase the maximum amount of Contract by \$250,000 from \$150,000 to \$400,000.
2. Extend the term of Contract by five years, ending November 30, 2021.
3. Change the Entire Contract Maximum on Page 1 to \$400,000.
4. Change the Unit Price amounts in the table on Page 1 as follows:
  - a. Line Item No. 1 "eSTREAM Modification and Extension, Documentation and Training, and Technical Support (Principal)" – Unit Price \$197.00 per hour.
  - b. Line Item No. 2 "eSTREAM Modification and Extension, Documentation and Training, and Technical Support (Senior)" – Unit Price \$157.00 per hour.

c. Line Item No. 3 "eSTREAM Modification and Extension, Documentation and Training, and Technical Support (Staff)" – Unit Price \$128.00 per hour.

5. Delete the not-to-exceed limit of \$851.00 per visit for Item No. 4 Travel Expenses in Accordance with Itemized Expenses on Page 1.

Except as herein amended, all other terms and conditions of Contract shall remain the same and are incorporated herein as fully set forth.


