Shane Murphy Goldsmith

Shane Murphy Goldsmith is President and CEO of Liberty Hill Foundation, which funds and provides leadership training for community based organizations in L.A. County, empowering low income communities of color with the tools to solve the challenges they face. Under her leadership, the Foundation's priorities are racial justice, economic justice, environmental justice, and LGBTQ justice.

Ms. Goldsmith has spent two decades bringing together diverse groups to resolve conflicts and achieve innovative solutions to social problems. Her leadership is informed by principles of fairness and justice, and the belief that the search for common ground can build trust and fellowship in place of mutual suspicion.

Her work in building community-based solutions is rooted in her family experience. Raised in poverty and orphaned in her late teens, Goldsmith and her family grappled in her early life with a sense of powerlessness in the face of many of the conditions endured by communities in crisis: poverty, lack of access to treatment for physical and mental illness, educational obstacles and exposure to crime and violence.

Prior to joining Liberty Hill, Ms. Goldsmith was the Executive Director of PATH Ventures, which builds housing for, among others, people who are homeless and mentally ill. There she met with members of communities surrounding project sites to get input about their concerns and collaborate with them on plans for architecture, programs, and security that would create a safe neighborhood for everyone.

Prior to that, she served for four years as a senior advisor to then-City Council President Eric Garcetti, overseeing a variety of field and legislative projects pertaining to housing,

economic development, public safety, and LGBTQ issues. In Mr. Garcetti's district, she helped create At the Park After Dark (now the Summer Night Lights program), a widely-praised crime prevention initiative, and Uniting Neighborhoods To Abolish Graffiti (UNTAG), a partnership of law enforcement, graffiti abatement agencies, and community members that drove a sharp reduction in graffiti with rapid response abatement rather than intensified law enforcement. Her legislative and community work on public safety brought her into close contact with officers in the field as well as command staff, and was characterized by collaboration and communication.

A graduate of Kenyon College, Ms. Goldsmith spent a year as a National Hunger Fellow managing a homeless shelter in Indiana. She received her Master's Degree in Public Policy and Administration at California State University, Long Beach, where she did her thesis on leadership development. In addition, she has experience as a paralegal with the Legal Aid Foundation in Los Angeles and the Washington, D.C.-based Center for Community Change.

Ms. Goldsmith is a member of the Los Angeles Board of Police Commissioners. She is co-chair of the California Funders for Boys and Men of Color So-Cal Region. She sits on the board of People Assisting the Homeless (PATH), and Southern California Grantmakers.
