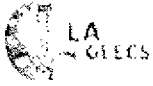

Several historic consultants researched and visited the property and determined that the property did not contain structures of architectural significance and that there is nothing architectural worth preserving.

The Cultural Heritage Commission's determination and recommendation not to designate the Hope property was unanimous

Dolores and Bob Hope's wishes were that their home not become a monument, but rather that the proceeds be used to help those in needs and veterans.

A designation would minimize the property's value and thereby minimize much needed funding to the Hope Foundation (the beneficiary of the property) for distribution to needed community organizations that provide hope for people in need and our nation's veterans.
