To the Transportation Committee:

I agree with the comments that Tony Hoover has stated below. There is a fundamental difference between sightseeing operators and tour/charter operators that is not made clear in this motion. It is the sightseeing operators that have created most of the problems highlighted in the motion, yet it seems that all buses are being blamed for the problems.

Tour/Charter operators fall under a multitude of federal and state regulations that give them authority to operate. In this category of operations, visitors are typically brought from other areas to visit locations such as Hollywood. These guests could include fellow Southern Californians, school groups from around the country, or tourists from around the world. These people want to come to the city to see the sights, as well as spend their money to buy local goods and services. When people choose to travel by bus into the city, it eliminates additional cars on the streets which in turn reduces congestion and pollution into the air. Travel by bus is also safe; it is the safest form of ground transportation available.

Sightseeing operators on the other hand are selling their product to visitors that are already in the city. They typically start and end their trips within the city. They are not bringing visitors into the city. I do believe that there are reputable sightseeing operators in the city, but there may be others that are not. There is not as much oversight or regulation on this type of business. They may very well require more regulations from the city in order create control (much like taxi operators are regulated by the city). However, a clear distinction must be made from these two very different types of business.

With that said, the tour/charter operators require the city's assistance in order to keep bringing those visitors into the city safely. We need places where our buses can unload, park and load safely. We appreciate the Councilmember's help with the trial bus parking program and hope that the iniquities of the sightseeing operators does not ruin everyone else's opportunity for a place to park while our visitors come to spend their money in the city. Unfortunately we find ourselves in a time when most cities are continually taking away parking making bus travel to those locations more difficult. While at the same time, clamoring for the tourists that are coming on those buses. If they make it too difficult, those people will look at other modes which may increase traffic and pollution, or they may not come at all.

We appreciate your consideration and understanding. I'd love to be able to address the committee in person, but unfortunately I am not able to make the meeting on such short notice. Please let me know if I can be of further assistance.

As I read this attachment I was feeling that we need to separate the "sightseeing" van operations operating off the sidewalk, from national "charter" coach operations. They are two very different and separate types of businesses.

The vans are the crux of the problems described in the motion. These people are not regulated. Many are fly by night operations.

Charter buses are highly regulated and are held to a very different standard.

You may also want to be in touch with the American Bus Association (ABA) http://www.buses.org/ to disseminate meeting information to their constituents (either locally or regionally) regarding these motions and issues. The ABA

can be a great resource for you in resolving issues relating to charter coaches specifically. Peter Pantuso is the President and CEO of ABA. I can make an introduction if you like.
