Summary: The CANNDU Neighborhood Council opposes PIMA Alameda Partners LLC proposed project, their Environment Impact Report (EIR) fails to fully address how this project will impact CD9 residents. Our community already suffers from bad air quality and their development will only increase diesel traffic and negatively impacting local schools, churches and residents. We support the restoration of the South Central Farm as an alternative plan to help bring organic food, clean air, green jobs, and park equity to all CD 9 residents. The South Central Farm Restoration Committee is proposing an alternative development that would better fit the needs of our stakeholder. Los Angeles, CA: Thirteen years after the forceful eviction of hundreds of urban farmers and their supporters from the historic South Central Farm, the community rallies in a lawsuit to Challenge the City of Los Angeles and current landowners.P.I.M.A. Alameda Partners, LLC (a clothing conglomerate: Poetry, Impact Mfg., Miss Me, Active Basic USA), over the Environmental Impact Report (EIR) and California Quality Act (CEQA) process for proposed new development on the site. The class action lawsuit, which includes residents of South Central LA and the South Central Farm Restoration Committee as plaintiffs,argues that the warehouse and distribution center proposed on the former South Central Farm site of 41st/Alameda Ave. in South Los Angeles would lead to dangerous new levels of local pollution from increased truck and car traffic and congestion. This would further undermine community health in an already heavily polluted residential area, while simultaneously losing an extremely rare opportunity on the 14 acre site to gain needed local open green space. Additionally--and in apparent violation of state law--residents have been denied the right to appeal "The City of LA violated CEQA when it refused to hear the appeal of the Project Approvals (i.e. the Subdivision and Site Plan Review) ... .
