Emma Howard, representing CD4, stated that Councilman Ryu’s Office is trying to work with the residents in the Bird Streets area. She stated that the two routes hauling at the same time is a better way, however, she would like to explore the capping provisions with staff and the constituents.

Approximately 14 concerned neighbors expressed reservations with using the two routes at the same time because it will double the amount of hauling trucks in the area that are already hauling.

Jamie Hall stated that doubling the amount of trucks hauling in the area is considered an environmental impact and that another CEQA analysis would be required.

Jason Somers, Tony Russo, and Ed Goldberg, were in support of the two proposed routes hauling at the same time, with 24 truck trips each.

He stated that when the lot was first occupied, there were no residential uses around and the tenant was unaware of any zoning codes or violations. Mr. Valle stated that they located another lot in an M2 zone; however, need the extension of time to obtain a lease for the property and get the land suitable for truck storage.

Staff stated that due to complaints made in regards to the unapproved use of the property, the Council Office would not support any extension of time to comply with the order.
