Prior to working on her first enterprise, Rebecca was the Community Relations and Policy Director at Clinica Monseñor Oscar A. Romero (Clinica Romero), where she was responsible for the design and implementation of strategic initiatives related to all levels of government and key community stakeholders, to offer care with respect and dignity to people with limited or no health insurance, without exclusion.

Previously, Rebecca served as a consultant and policy analyst for National Latina Institute for Reproductive Health (NLIRH) and a Congressional Hispanic Caucus Institute (CHCI) Edward Roybal Public Health Fellow for Congresswoman Roybal-Allard in Washington, DC. Prior to her D.C. experiences, Rebecca worked for the National Council of La Raza/California State University Long Beach Center for Latino Community Health, Evaluation, and Leadership Training, as well as AltaMed Health Services, and the County of San Bernardino Department of Public Health. In addition, her work on cervical cancer and Latinas has been published in the Harvard Journal of Hispanic Policy, and she has engaged in global and maternal health research and community development in Sri Lanka and Peru.

Rebecca left the healthcare world to start her own company because she was frustrated with her own shopping experiences and big spending. While she doesn't necessarily consider herself fashionable, she has individual style and good taste, but not the money to prove it. Through Found!t, she hopes to be a role model for women and other under-represented entrepreneurs and plans to donate a large percentage of the profits to charity.

You are required to complete and return this form **within 21 days** of your nomination to the City Ethics Commission, 200 North Spring Street, City Hall, 24th Floor, Los Angeles, California 90012. Sometime thereafter, you will be notified by the committee clerk when your appointment will be presented to the full City Council for confirmation. Once you are confirmed, you will be required to take the oath of office in the City Clerk's Office in Room 395 of City Hall. Claudia Luna will assist you during the confirmation process if you have questions.

Commissioners must be residents of the City of Los Angeles. If you move at any point during your term, have any changes in your telephone numbers, or in the future plan to resign (resignation must be put in writing), please contact my office immediately.
