Fellow CCCHA Homeowners,

Lots of activities going on in our community. As we've been reporting, the City Council is about to pass the Baseline Mansionization Ordinance and the related R1 zoning variations, which will impact our neighborhood for many years. As a reminder, we anticipate that we will be subject to the R1V2 variation (formerly R1VNew). There are some last minute changes being proposed that would eliminate from the FAR calculation the currently proposed 200 square-foot exemption for a front-facing garage (impacts most, if not all, of us). We are working with the Council Member's office to try and resolve this issue. Stay tuned.

You will have a chance to hear directly from our Council District 5 candidates for City Council this Sunday, February 19, 2017 from 4-6pm at a Town Hall being co-hosted by the CCCHA, Beverlywood HOA and Cheviot Hills HOA. See attached flyer for particulars.

Council Member Koretz's office has asked us to let you know about an upcoming Community Open House to discuss potential improvements to the I-10/Robertson/National freeway ramps, which will be held Thursday, March 2, 2017 from 5:30-7:30pm at Hamilton High School. See attached for particulars.
