To Whom It May Concern:

We are owners at the Eastern Columbia Building at 849 South Broadway. We are writing to express our strong opposition to the Alexan Project that is proposed for the space directly adjacent to the Eastern Columbia.

This proposed project is out of scale with the neighborhood. It is too large It would obscure the iconic clock tower of the Eastern Columbia building. It would be so close to the Eastern Columbia that residents on that side of the building will lose significant natural light and have a huge building mass right outside of their windows, significantly decreasing their privacy as well. This project, as currently proposed, would also significantly impact the rooftop area of the Eastern, and have a significant impact on its quality.... We believe a new EIR should be required because the proposed building blocks the view shed of five historic monuments. There are alternate design options available, including the original proposed design.

We also understand that the correct process for public hearings, etc., was not followed, and wish to express our frustration regarding this lack of correct process.

We urge you to deny this application in its current form, and ask the developers to come up with a plan that does not degrade the downtown historic core.
