Comments for Public Posting: I strongly support the ADU program. Not only will it help to ease our housing shortage but it will also help our affordability issue. By using the additional income from an ADU, a home buyer now has a better chance of becoming a homeowner. I just completed an ADU project in Los Angeles and we ran into two important issues. First, regardless of the total amount of square footage you can build based on the FAR guidelines, LADBS is not allowing a detached ADU to be larger than the existing front house. So if your front house is smaller than 1,200 sqft than you cannot build a 1,200 sqft ADU. Providing the FAR ratio allows it, you can expand the existing house first and then you can build the ADU to a larger size. This is the challenge. Before you can apply for the permit to build the larger sized ADU, LADBS is requiring you to expand the existing house first, get the certificate of occupancy, and then wait until the increased square footage RECORDS through the Tax Assessors Office. That last part could possibly take over a year. This makes no sense. You can't game the process because LADBS still controls the issuing of the certificate of occupancy. If a homeowner didn't in fact build everything they got a permit for than they would not receive there Certificate of occupancy. Why make people wait? I am very happy with these new proposed changes to the Los Angeles ADU ordinance. Let's keep improving and growing our SMART CITY.
