MOTION

On April 13, 2018, Council authorized the General Manager of the Los Angeles Housing + Community Investment Department (HCIDLA) to negotiate and execute an agreement with the Coalition for Economic Survival (CES) to provide educational outreach services to property owners and residents who are at-risk of losing affordable housing (C.F. 17-0027). The one-year term of the agreement was approved to start retroactively from January 1, 2018, and end December 31, 2018, with two one-year renewal options, and in an amount not to exceed \$103,000.

Subsequent to the approved Council action, the CES submitted a request to the HCIDLA to delay the contract start date until July 1, 2018. The HCIDLA concurs with the request from CES since services to date have not begun.

I THEREFORE MOVE that City Council authorize the General Manager of the City of Los Angeles Housing + Community Investment Department to amend the term of the agreement with the Coalition for Economic Survival, to start effective July 1, 2018 and to end June 30, 2019.
