**Comments for Public Posting:** I am a Chatsworth resident writing to object to the proposed homeless apartment development on Topanga, south of Devonshire, in Chatsworth. I am in favor of supportive housing and services, as the homeless issue has reached elevated levels in our area. What I am not in favor of is the location in question. The proposed site is across the street from an elementary school, down the street from three preschools, and at an extremely busy intersection. Pedestrian traffic is not optimal at that intersection because only three crosswalks are available, and presumably the people living in those apartments will not have cars, given that only five parking spaces are allotted to the development. The proposed building is a six-story structure on a small lot backed onto one or two-story single family homes. There are no structures over three to four stories high in the area, including nearby apartments, hotels and commercial buildings. A building of that height and density would be inappropriate for that site when there are other locations within Chatsworth that would support a more spread out, lower height profile building. Also, the amount of money proposed to build each of the 64 units, which I understand would be studio apartments, costs more than what most 2-3 bedroom apartments and condos are selling for in the area, for far less livable space. The numbers for this development do not make sense, and the amount of services reported to be made available to residents of the building do not appear to offer much more than a manager, laundry and outdoor patio facilities. Given that more issues than housing need to be addressed to successfully assist in creating coping skills for the residents of the proposed facility, a location that can additionally offer counseling (to treat substance abuse and psychological issues, for example) and occupational skills would better serve those intended residents. There are concerns that this will also bring more crime to the area, which we are already experiencing with the current homeless situation, and that is another worry with the location being so close to schools. This proposal does not make the best use of the HHH funding, take into account the logistics of the location and dimensions of the building vis-a-vis the surrounding area, nor does it offer enough services to the people it is intending to help. I strongly urge the Council to reconsider this plan and search out more viable locations in Chatsworth to comply with their challenge of

providing supportive housing in each Council district and to better serve the community as a whole. Thank you.

**Comments for Public Posting:** I am informed that there is a proposal to open a SEVEN story homeless shelter in the small lot adjacent to the Arco station on Topanga and Devonshire. I believe the purchaser of this parcel is looking to exploit the homeless propositions that will provide him ample financial reward (I understand he could potentially make upwards of 70 million dollars) while destroying the neighborhood around it. I oppose this being built at the proposed location for several reasons. 1) This proposed facility is mere yards from an Elementary school. The facility will have an on site mental health specialist. This means there will be people there with mental health issues. Is this an appropriate site for a mental health facility??? 2) There is a lack of parking. Only 4 parking spaces are proposed. Many single homeless people live in their cars. Will the City require the cars to be sold or parked in other parts of the City if the person is accepted in to this facility? How will this help their situation. 3) The proposed tower will be the tallest building west of the 405! Currently the tallest building in the west valley is the Chatsworth Courthouse. There is currently a height restriction on buildings in the Devonshire/Topanga corridor that this building will far exceed. 4) Cost! This building will essentially be built with public funds at a projected cost of more than \$400,000 per unit. The building will be owned by the private developer. Why should the developer own the building while we pay for it, to the detriment of the value of the surrounding homeowners? Other locations have been forwarded by concerned members of the Chatsworth Neighborhood Council to the city for consideration. When will these suggestions be discussed? Yes, the homeless crises needs to be addressed, however this is not a reasonable solution. The profits of the developers are being put ahead of common decency towards the citizens of Los Angeles and without regard for the local communities they are affecting. Lets find a solution that is acceptable to the Chatsworth Neighborhood Council and hold the developers responsible for more of the cost.
