The proposed location is less than 500 feet from our community elementary school. North of the elementary school is a daycare center. We have so many vacant lots and abandon buildings around Chatsworth that would be more suitable for this type of establishment. The people of Chatsworth are not against the building of a homeless facility but we strongly feel this is NOT the appropriate location. Councilman Lee was not my first choice but he was elected to keep the best interest of our community at heart. The students and parents to date have had several unpleasant encounters with mentally unstable homeless. A woman standing on the corner yelling at the children and parents as they were walking to school. A man standing on the corner naked (happened during non school hours) but on the corner of Devonshire and Topanga (gas station corner) Parents and student walking from the donut shop to school while being followed by homeless asking from money.
