This facility may house drug users or recovering drug users which will put young children's lives at stake. Will it also house ex criminals, mentally ill and sex offendors? The property will not have parking and therefore either crowd neighboring residential areas with parked cars or the tenants will park near the school. The children may be exposed to drug users or at increased risk of being struck by a vehicle driven by someone under the influence of drugs or alcohol while walking to or from school. Students who walk to school will pass this facility as well. **Comments for Public Posting:** Hello, I write to express my concerns regarding the homeless housing project proposed for 10243 N. Topanga Cyn Blyd in Chatsworth. I believe that this location is a poor choice for reasons that I will outline in this message. I am not opposed to identifying a more appropriate site and I am confident there are many to choose from within CD12. Here are my concerns: 1. This facility is located too close to Chatsworth Park Elementary, Monarch Christian School, Chatsworth Park South and the Chatsworth Community Center. I do not believe that is appropriate to place this facility in such close proximity to children. 2. The proposed location is an already heavily trafficked corridor. This would add additional vehicles in an already crowded and accident prone intersection. Additionally, 5 parking spaces for a building of this size strikes me as completely unrealistic and insufficient. 3. The scope of this building is completely out of line with the rest of this community. There is not a single building within miles that exceeds 3 stories. This is an insult to the aesthetics of our beautiful community. 4. While I do not live or own a home behind this proposed facility, I wish to express concerns on behalf of my neighbors (I live approximately 1 mile from this site) who do. They will lose all privacy with a building of this height located adjacent to their homes. 5. The cost to build this facility is staggering! How can this be a justified use of HHH funds? There is not one home or building in the area that costs this much to build nor do any of our homes sell for this price when looking at square foot figures. This is an irresponsible use of tax payer funds! 6. I have no faith that this facility will serve the homeless who come from our actual community. I also have no faith that it will do anything to decrease the daily issues we face with the crime/trash/graffiti associated with transient drug addicts living on the streets, along the railroad tracks or in the many RV's parked in CD 12. As stated above, I am not objecting to building a homeless housing project within CD12. Our community certainly needs help, but this proposal is not the answer.
