

Honorable Members:

As requested by the City Council, this Office has prepared and now transmits for your consideration the enclosed draft ordinance, approved as to form and legality. The draft ordinance would add Article 6.7.1 to the Los Angeles Municipal Code (LAMC) to require firearm stores and firing ranges to post suicide prevention information within their premises.

This draft ordinance would require firearm stores and firing ranges to display a sign containing suicide prevention information in a conspicuous place inside their business. The displayed sign must contain the hotline number for the National Suicide Prevention Lifeline, which is a leading national suicide prevention nonprofit organization. The sign must meet minimum size requirements and be available in other languages if more than 20 percent of the customers patronizing the business primarily speak a language besides English.
